Because I have been given ten days to respond I am resending the 11 August 2017 certification of counsel where I am assuming that you may have overlooked the original document.

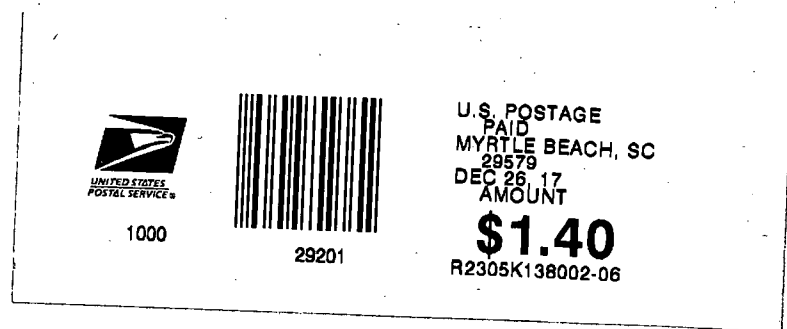
If you need some other document please advise where I will do my best to comply with any deficiency letter.
