




Dear Clerk:

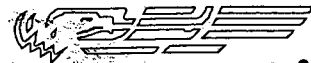
