Motion for Extension of Time to file Reply Brief and as grounds therefore allege:


1. Appellant is Pro se and has been working diligently and in good faith on the Record on Appeal, but needs additional time to prepare and get copies and binders put together.

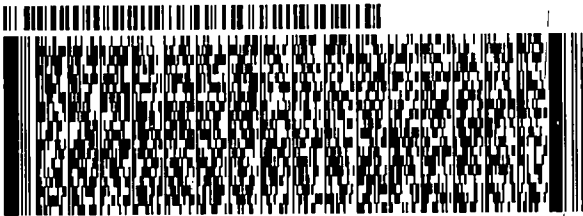
