
EXPLANATION OF APPEAL

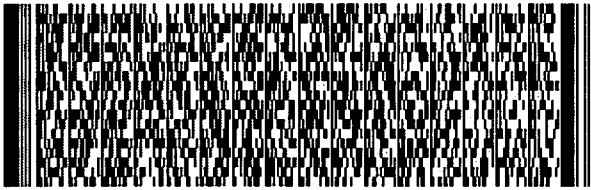

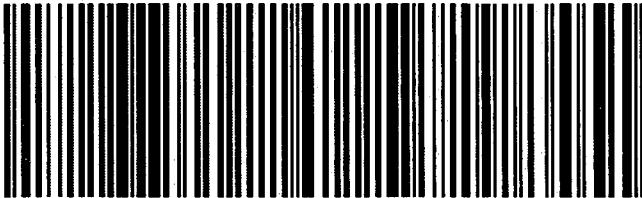
