MOTION FOR AN EXTENSION OF TIME
IN WHICH TO FILE THE PETITION
FOR WRIT OF CERTIORARI AND APPENDIX

Counsel for Lee Edward Tate respectfully requests a **final thirty (30) day extension, until February 5, 2018**, in which to file the Petition for Writ of Certiorari and Appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a third request for an extension. In support of this request, counsel shows:

1. The Petition for Writ of Certiorari and Appendix are due to be served and filed with the Court today. The Court has granted counsel two previous extensions.
2. Counsel for Lee Edward Tate respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the

number of extensions previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.

Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Jerry Lee Dickey v. The State with the Supreme Court on December 6, 2017. Counsel was a guest speaker at the Appellate Practice Project: Presenting Cases to the Appellate Courts seminar on November 30, 2017. Counsel filed the petition for rehearing in the case of The State v. Michael Antonio Williams with the Court of Appeals on November 29, 2017. Counsel filed the petition for writ of certiorari to the Court of Appeals in the case of The State v. Lance Leon Miles with the Supreme Court on November 14, 2017. Counsel had an oral argument in the case of The State v. Keyon Robinson before the Court of Appeals on November 8, 2017. Counsel had an oral argument before the court of Appeals in the case of The State v. Antwan J. Jett on November 7, 2017.


4. Counsel makes this request in good faith and not for purpose of delay.

5. Counsel for the Attorney General's office has been informed of this request as shown by signature below.




