APPELLANT'S MOTION REQUESTING AUTHORIZATION
TO FILE A SUPPLEMENTAL BRIEF

WHEREAS, Appellant Polly M. Hindman ("Hindman") has heretofore requested the Court of Appeals for leave to file a Motion for a New Trial on the Ground of Newly Discovered Evidence; and the Court of Appeals granted Hindman leave to file such Motion; and

WHEREAS, Hindman filed her Motion for a New Trial in the Court of Common Pleas; and

WHEREAS, Circuit Judge Edward W. Miller in an Order, dated November 8, 2017, but not received from the Clerk of Court for Greenville County until November 30, 2017, denied Hindman's Motion for a New Trial on the Ground of Newly Discovered Evidence; and

WHEREAS, Hindman filed a Notice of Appeal to the Clerk, Court of Appeals on December 6, 2017, from the November 8, 2017 Order of Circuit Judge Edward W. Miller.

Hindman now moves that the Court of Appeals grant her leave to file a Supplemental Brief in support of her appeal from the Order, dated November 8, 2017; and


