MOTION FOR AN EXTENSION OF TIME
IN WHICH TO FILE THE INITIAL BRIEF OF APPELLANT
AND DESIGNATION OF MATTER

Counsel for Terrance Lamar Tyson respectfully requests an extension of a **final thirty (30) days, until February 5, 2018**, in which to file the Initial Brief of Appellant and Designation of Matter in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a fourth request for an extension. In support of this request, counsel shows:

1. The initial brief of appellant and designation of matter are due to be filed with the Court today. The Court has granted counsel three previous extensions.
2. Counsel for Terrance Lamar Tyson respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the

Counsel filed the Initial Brief of Appellant and Designation of Matter in the case of The State of South Carolina v. Jamie L. Strom with the Court of Appeals on November 29, 2017. Counsel filed the Petition for Rehearing in the case of The State of South Carolina v. Christopher Jermaine Wells with the Court of Appeals on November 22, 2017. Counsel filed the Petition for Writ of Certiorari and Appendix in the case of Kristopher Wilmont Berry v. The State of South Carolina with the Supreme Court on November 17, 2017. Counsel filed the Johnson Petition for Writ of Certiorari and Appendix in the case of Elijah A. Brown v. The State of South Carolina with the Supreme Court on November 16, 2017. Counsel filed the Return to Petition for Writ of Certiorari in the case of Robert Eugene Shaver v. The State of South Carolina with the Supreme Court on November 15, 2017. Counsel had an oral argument in the case of The State of South Carolina v. Stephen Smalls before this Court on November 14, 2017. Counsel filed the Petition for Writ of Certiorari and Appendix in the case of Demetrius D. Smalls v. The State of South Carolina with the Supreme Court on November 13, 2017. Counsel filed the Johnson Petition for Writ of Certiorari and Appendix in the case of Timothy Donald Dingle v. The State of South Carolina with the Supreme Court on November 13, 2017. Counsel filed the Initial Brief of

Appellant and Designation of Matter in the case of The State of South Carolina v. Michael N. Frasier with the Court of Appeals on November 7, 2017.

4. Counsel makes this request in good faith and not for purpose of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.

5. Counsel for the Attorney General's office consents to this request shown by signature below.




