
**APPELLANT'S MOTION FOR EXTENSION TO FILE INITIAL BRIEF AND





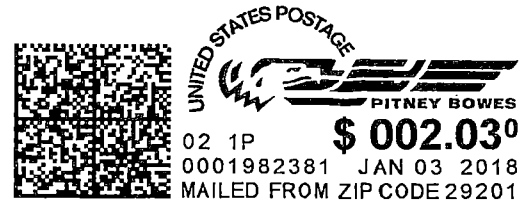
