Given these circumstances, Appellant respectfully requests an additional thirty (30) days in which to file Appellant's Initial Brief.


Appellant's counsel reached out to counsel for Respondents Thompson and Fogarty for consent to Appellant's request, but has not received a response as of the forwarding of this request.

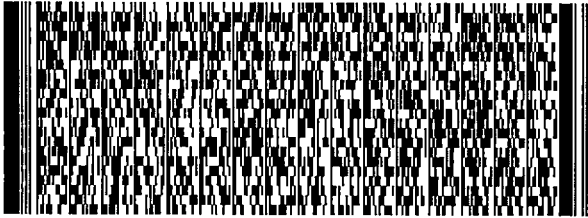

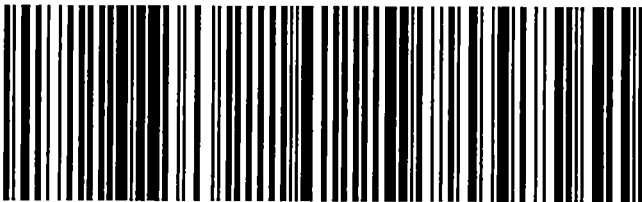
