on my warrant it stated that the CSC was
my intent upon entering the residence, which
made it Burglary 1st event though I had permission
to come in I had intent to commit a crime.

Well at my preliminary hearing I proved that
CSC never happened, so they indicted me
for assault battery 1st degree. My original
intent was to just use my neighbor's phone

I was under the influence and made a
bad choice to take the phone from the girl
and put my hands on her. I was wrong
for what I did and I know it but if
there is a chance that we can get this
Burg dropped down to a 2nd degree and get my
time down to 10 years and my kidnap to 10 years

my assault is already 10 years, I feel that will be a more fair sentence. I have some witness statements on my side among other things if it comes to the point were I need people on my side I have alot of support and alot of people to speak of my character, what type of parson I am. Please do anything you can, My mother's name is
