

Please also find a check for twenty-five (25.00) dollars for the cost of this request.

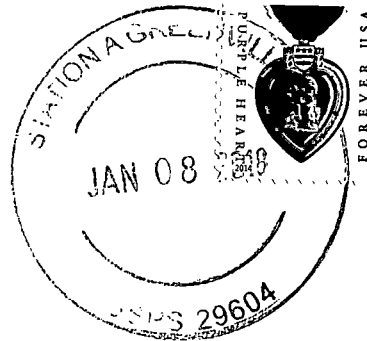
