
MOTION FOR EXTENSION OF TIME TO FILE PETITION FOR WRIT OF



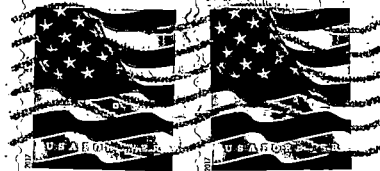
