
NOTICE OF APPEAL

Alan G. Nix, Norma J. Nix and the Estate of Norma J. Nix appeal the Order of the Honorable Mikell R. Scarborough, dated November 9, 2017. Appellants received written notice of the entry of this order on November 16, 2017 and filed a Motion to Reconsider on November 22, 2017. The Master in Equity, in error, scheduled the Motion to Reconsider to be argued on November 29, 2017, adding it to the Motion Roster after 4:30 PM on November 28, 2017 for a motion hearing at 9:30 AM November 29, 2017. Appellant received written notice of entry of the order denying the motion to reconsider on December 8, 2017.



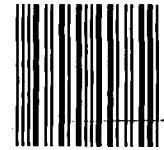
