
Re: Request for Time Extension to File Pro-se Response

Thank you in advance for your prompt reply and assistance in this matter.

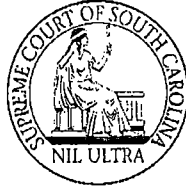

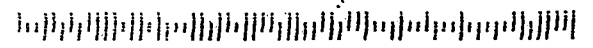
