I. Statement of the Case:

This is an appeal from a Seizure Hearing held in the Court of Common Pleas in and for Horry County, South Carolina in the matter of Jimmy A. Richardson, II, Solicitor For The Fifteenth Judicial Circuit, On Behalf of the 15th Circuit Drug Enforcement United Versus Twenty-One Thousand and no/ 100 Dollars (\$21,000.00) U.S. Currency and Various Jewelry, Defendant Property; Marvin Joshua White, Defendant.

On December 6, 2016, the Honorable Cynthia Howe, Master in Equity, conducted a hearing at the Horry County Government and Justice Center in Conway, South Carolina. At that time the Defendant Marvin Joshua White was represented by Ralph Wilson, Attorney at Law. At the conclusion of the Seizure Hearing a timely notice of appeal was filed with the Clerk of the Common Pleas Court and thereafter the South Carolina Court of Appeals assigned appellate number 2017-002365.

By Order dated December 18, 2017, the South Carolina Court of Appeals scheduled this appeal for appellant's initial brief and designation of matter to be submitted by January 12, 2018. The Appellant, Marvin Joshua White, a federal prisoner confined at the Federal Correctional Institution located in Salters, South Carolina and his attorney Ralph Wilson, Post Office Box 860, Conway, South Carolina 29528, have had a conflict of interest which prevents the Appellant from meeting the January 12, 2018, initial briefing and designation of Matter in this appeal.

II. Reason[s] For Enlargement of Time:

The Appellant, Marvin Joshua White a person confined at the Federal Correctional

Institution located in Salters, South Carolina and his former attorney Ralph Wilson has experienced a conflict of interest in this matter and as such the Appellant cannot prepare and submit his initial brief within the January 12, 2018 date set by this Court.

TO THE HONORABLE JUDGES OF THE COURT:

COMES NOW, Marvin Joshua White, the Appellant, pro se, and respectfully moves this Honorable Court for a thirty (30) day enlargement of time pursuant to South Carolina Rules of Appellate Procedure to file Appellant's Initial Brief. Appellant will show this Court as follows:

1. This is appellant's first request for an enlargement of time to file Appellant's Initial Brief.
2. Appellant currently represents himself pro se. He has no training in the field of law and needs the additional time to properly prepare and file his Initial Brief.
3. Appellant works full time at his place of confinement and he has limited access to the law library. Appellant needs the additional time to conduct his own research and to properly prepare his Initial Brief in light of the conflict of interest between himself and his former attorney Ralph Wilson.
4. This Motion is made in the interest of justice and is not meant to delay the proceeding. The Defendant[s] will not be prejudiced by the delay.

5. The Defendant[s] have not expressed any opposition to the foregoing request for enlargement of time.

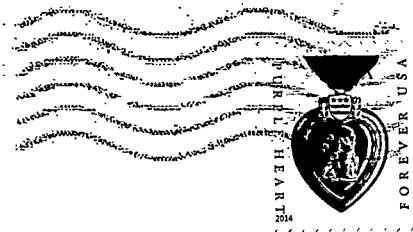
