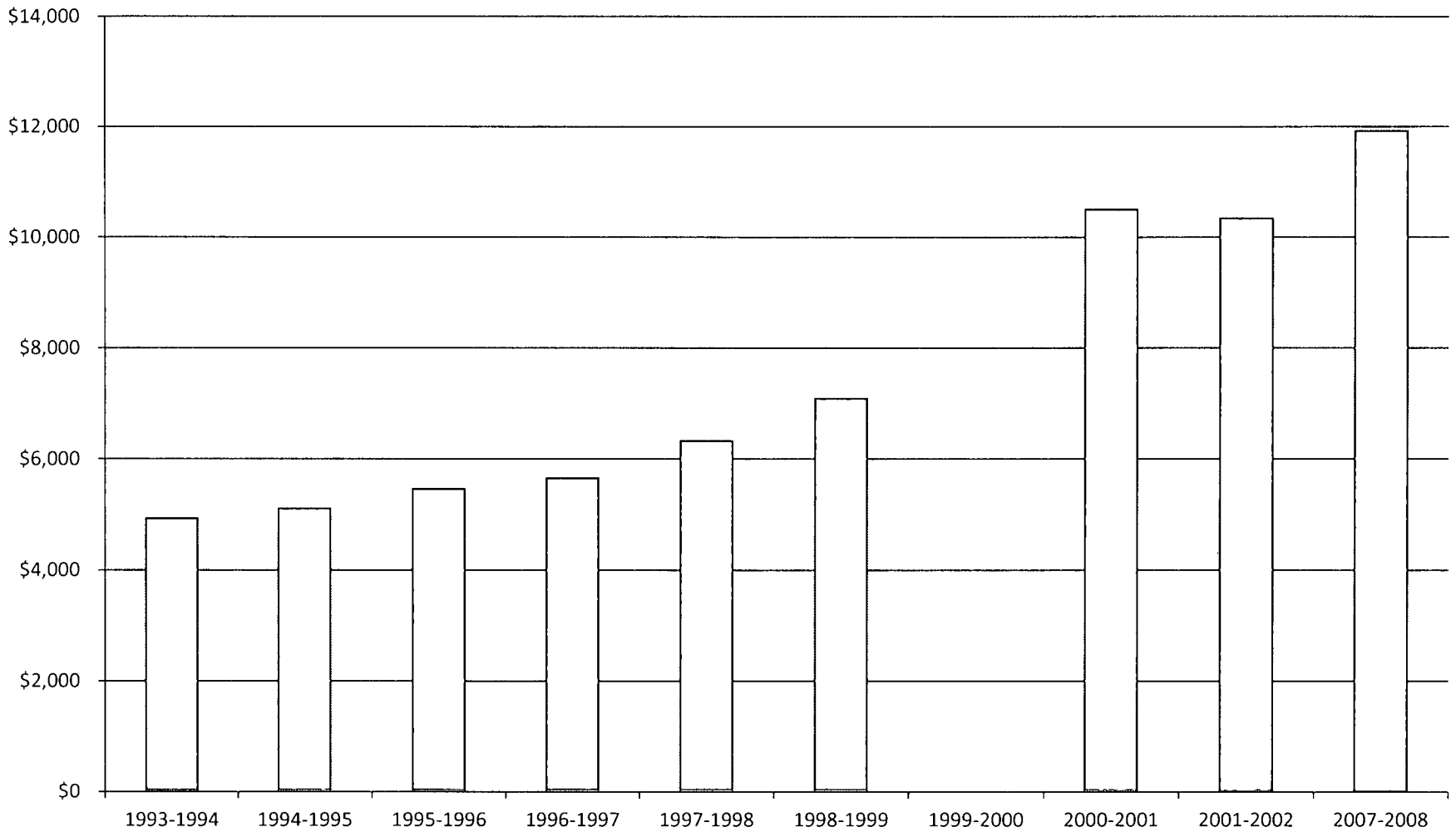

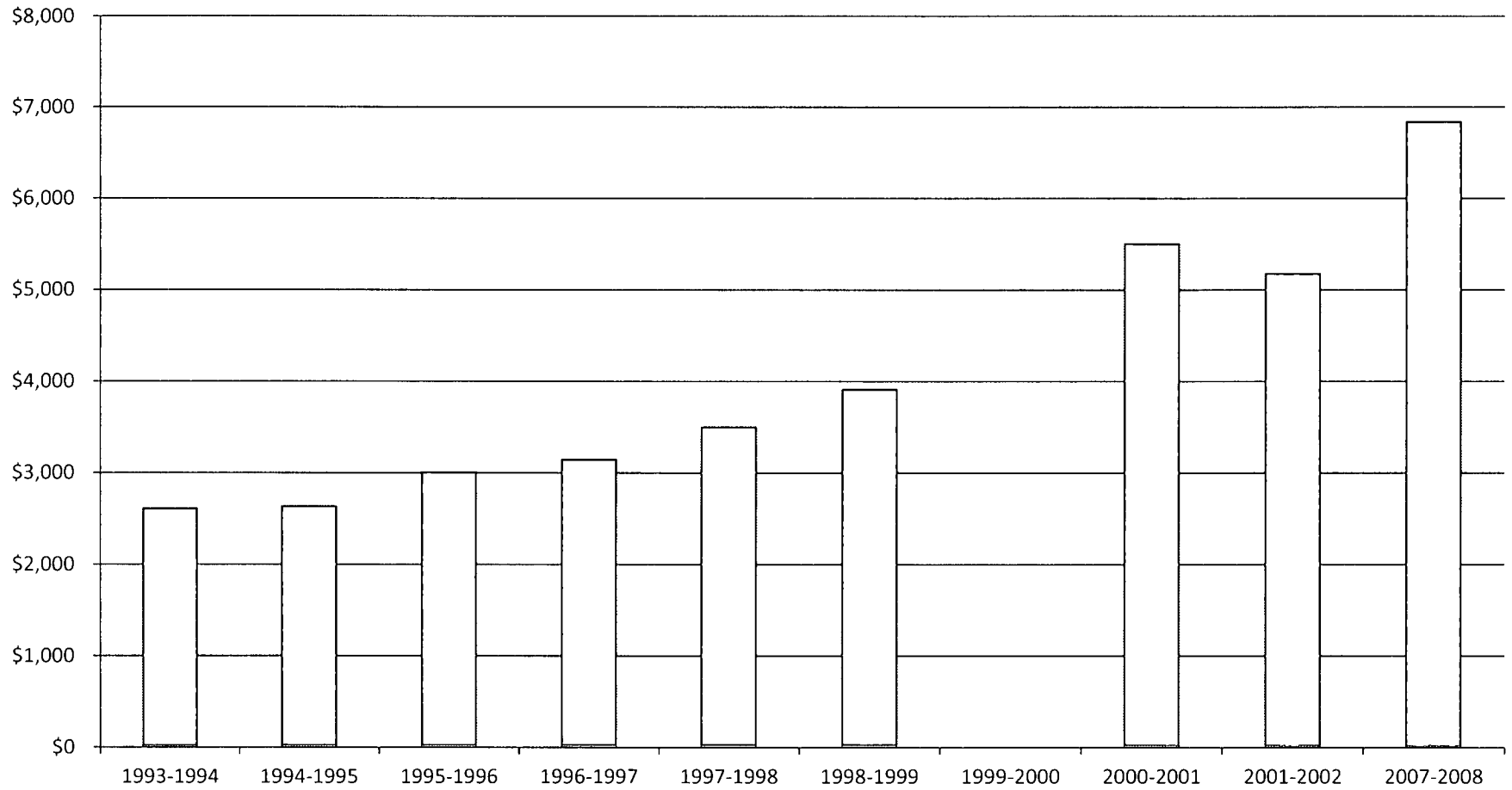

Allendale - Revenue Per Pupil from Local, State and Federal Sources



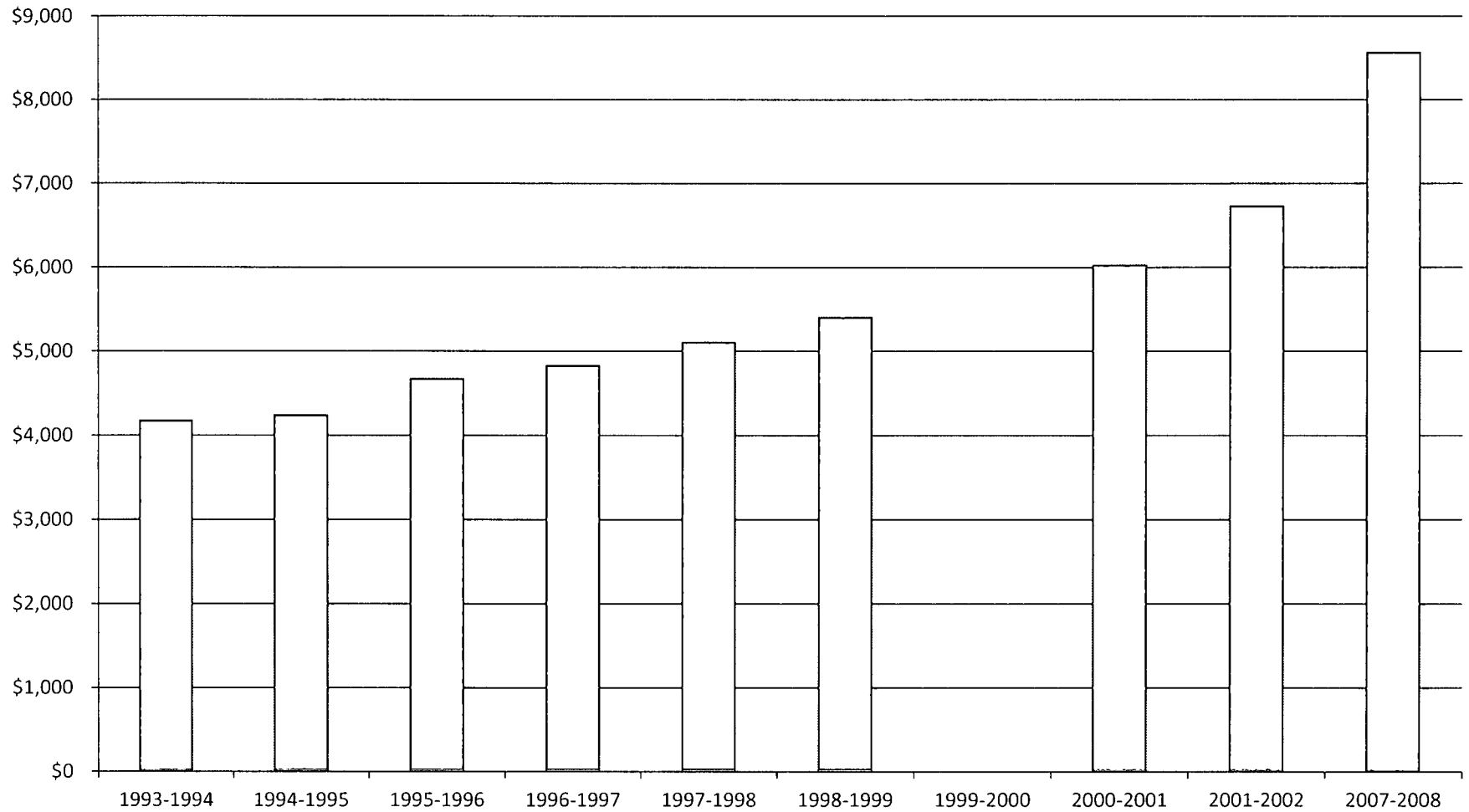

Allendale - Revenue Per Pupil from State Sources



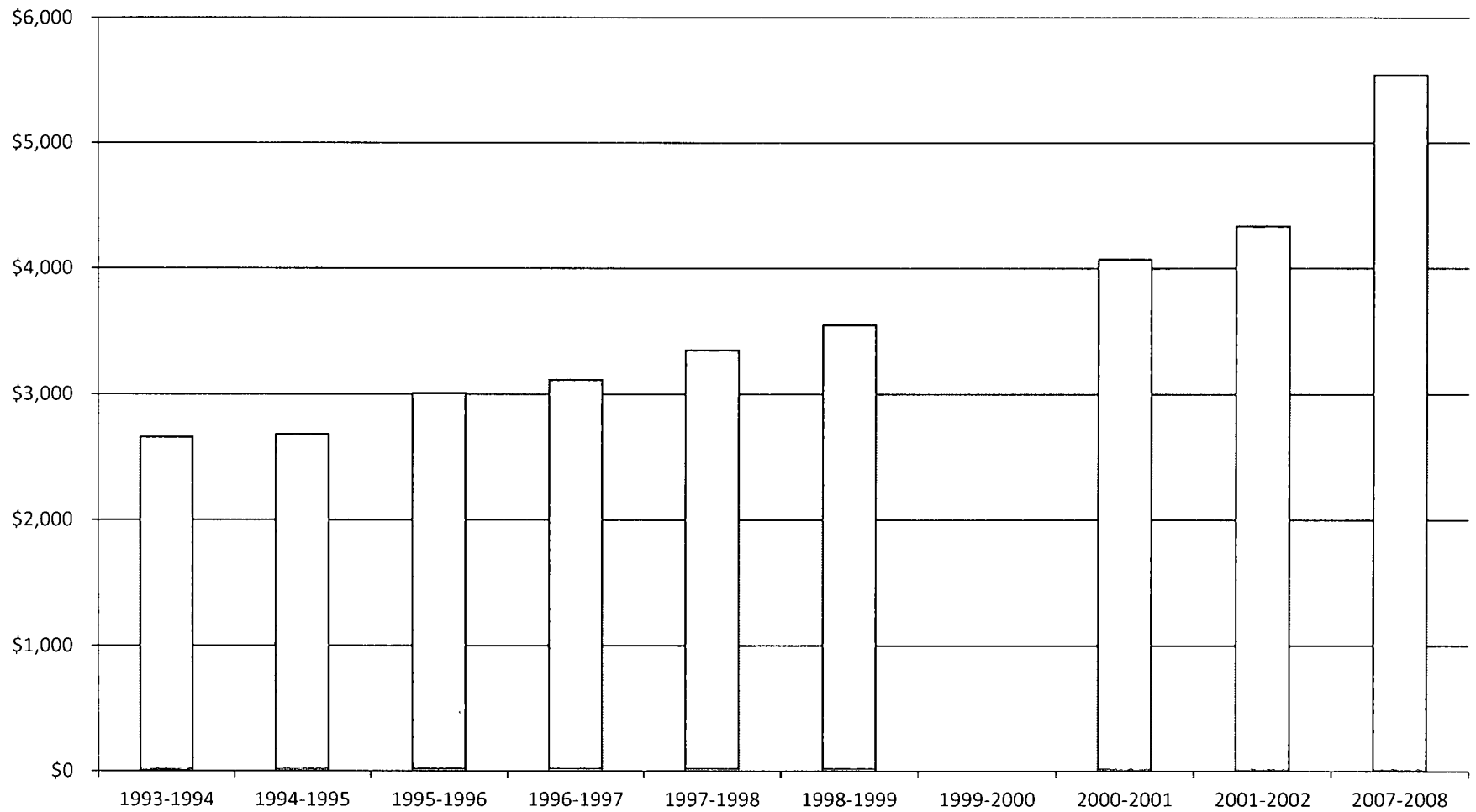

Dillon 2 - Revenue Per Pupil from State, Local, and Federal Sources



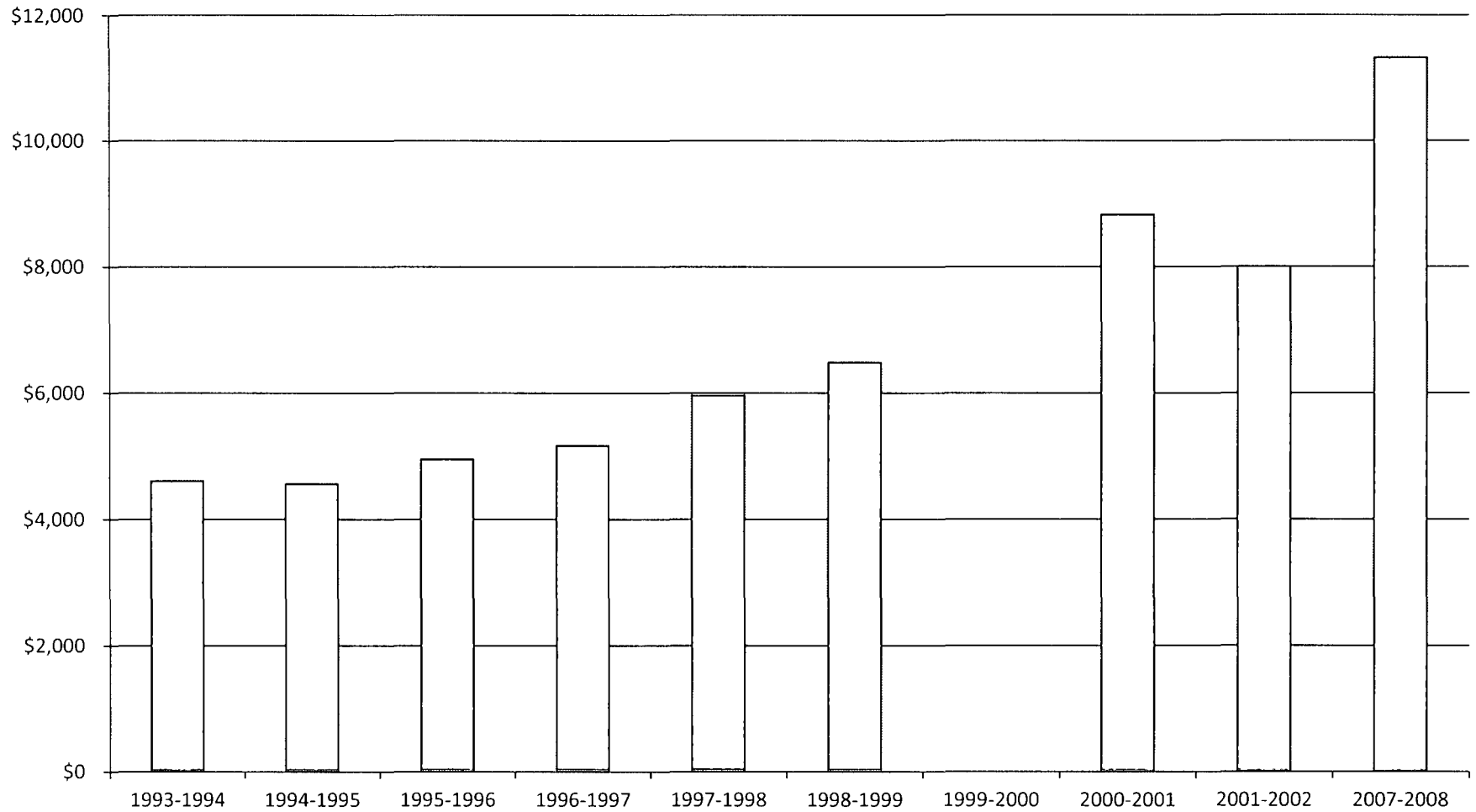

Dillon 2 - Revenue Per Pupil from State Sources



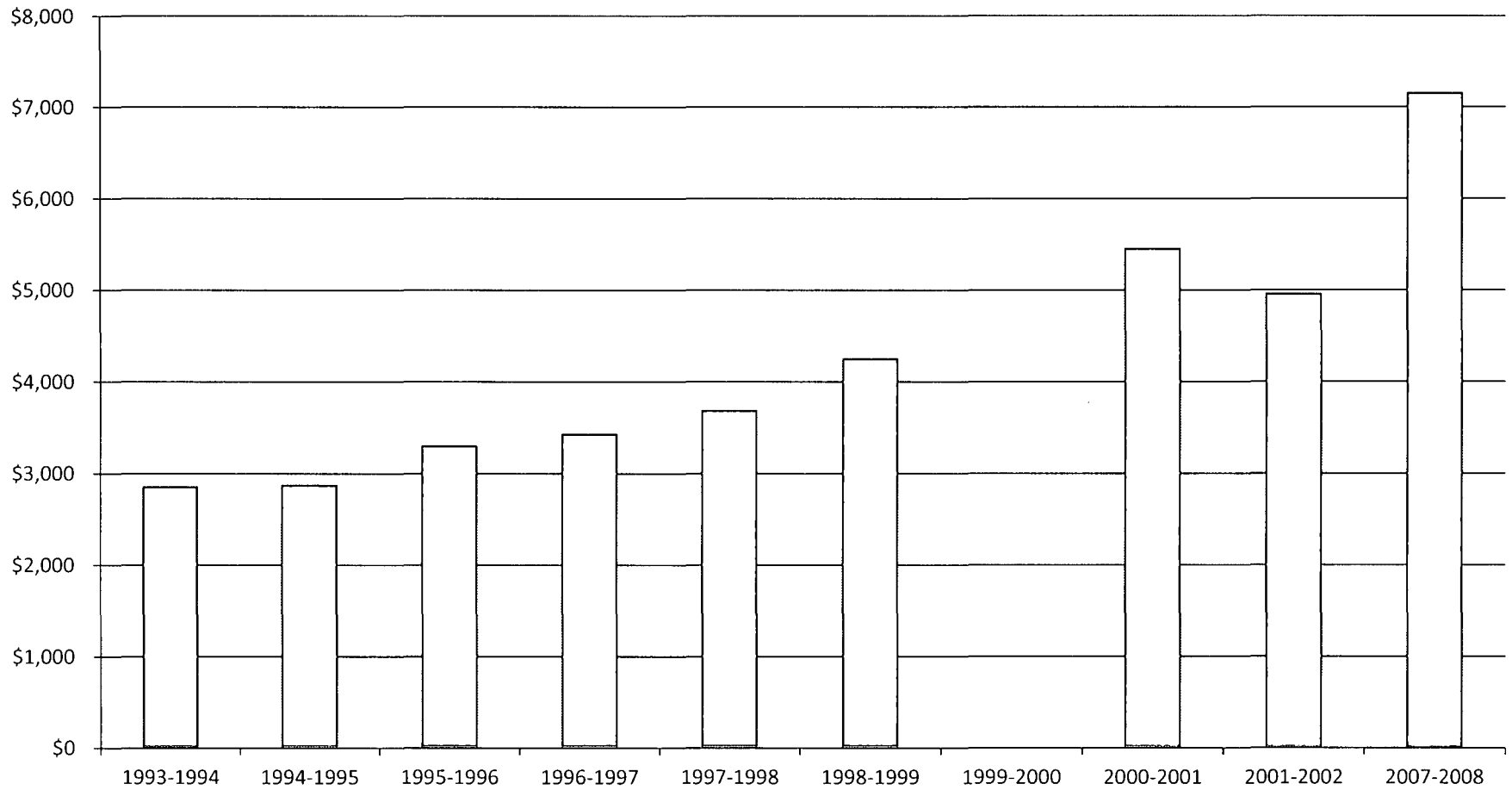

Florence 4 - Revenue Per Pupil from State, Local, and Federal Sources



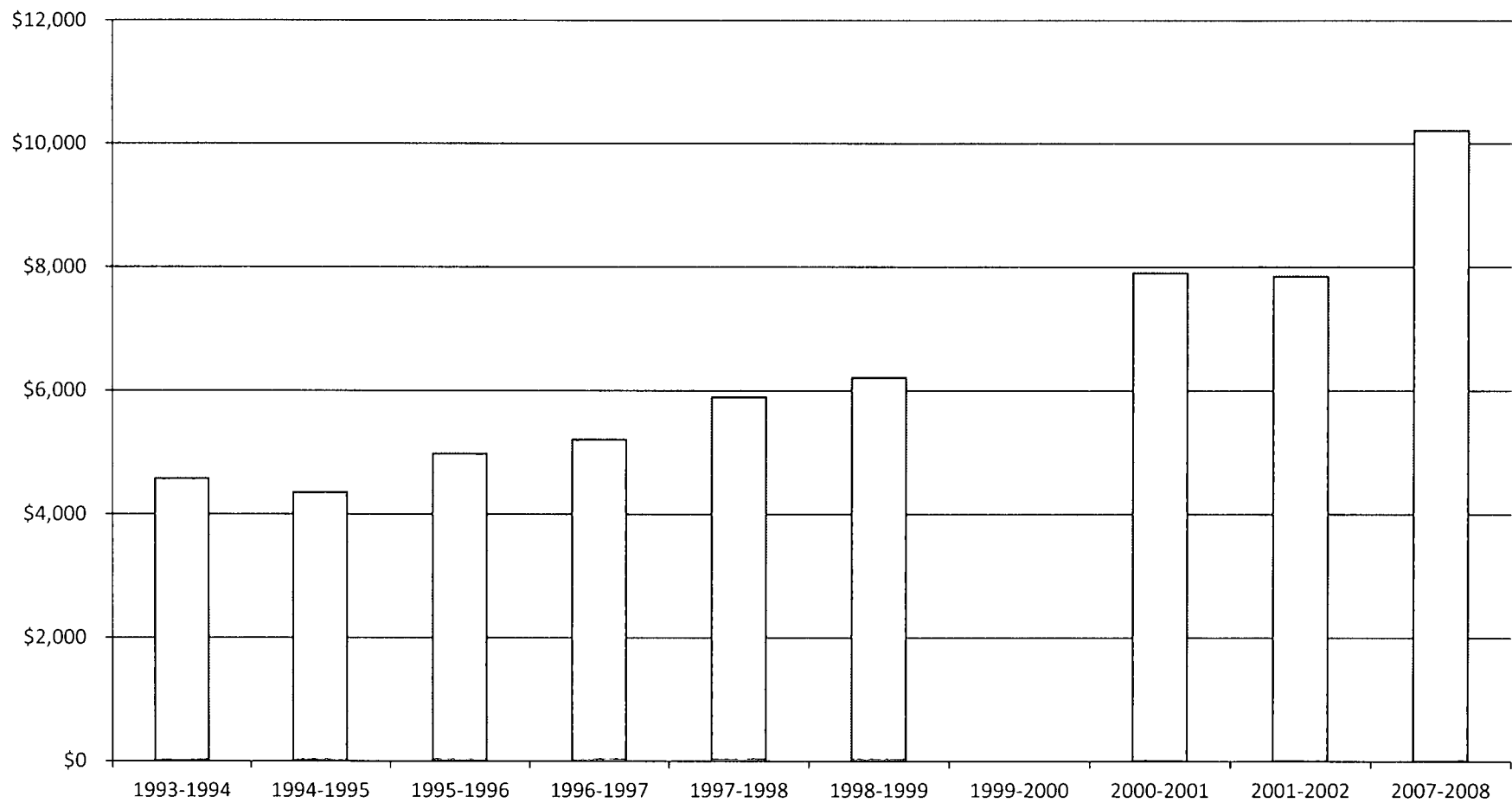

Florence 4 - Revenue Per Pupil from State Sources



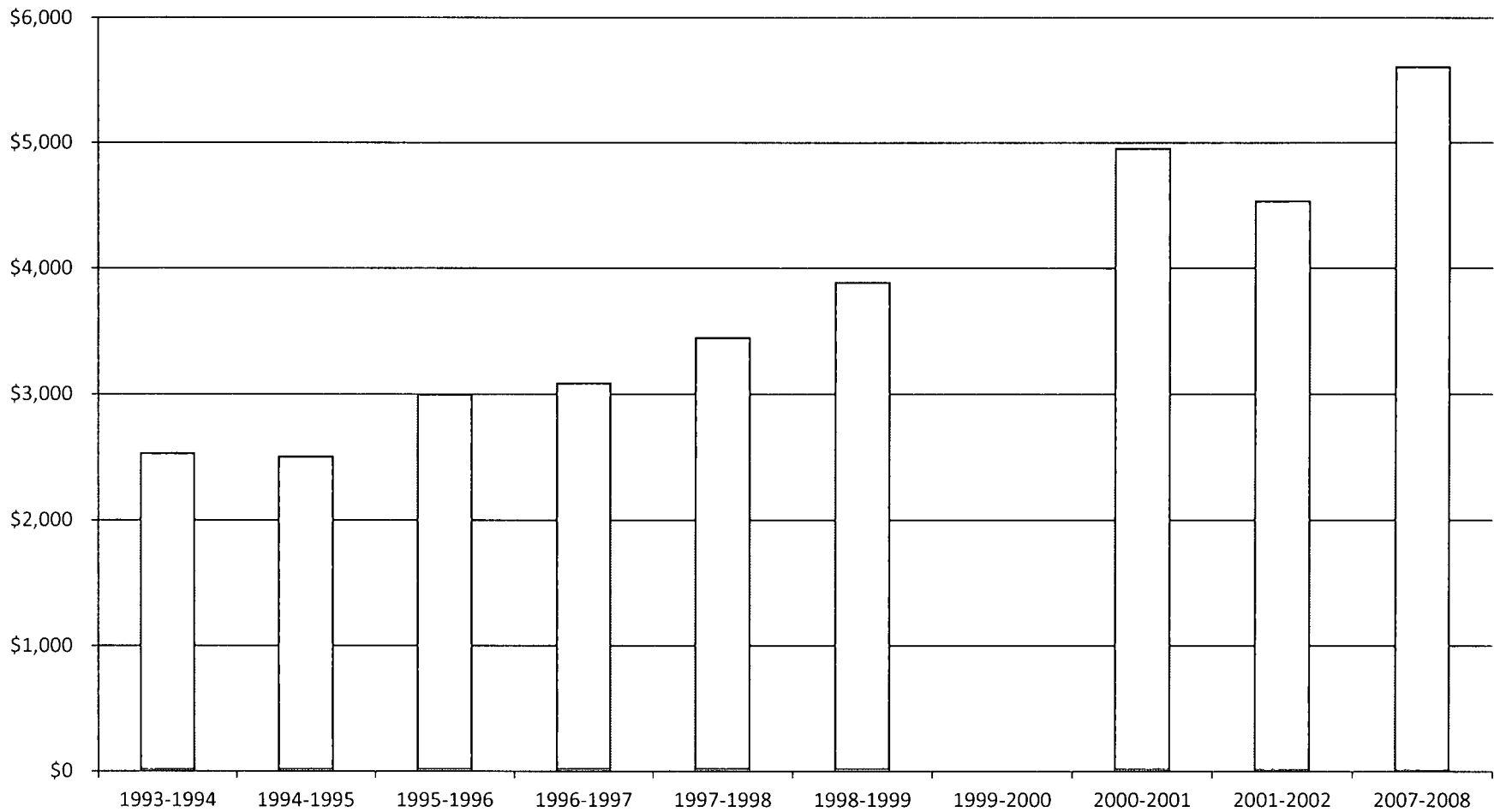

Jasper - Revenue Per Pupil from State, Local, and Federal Sources



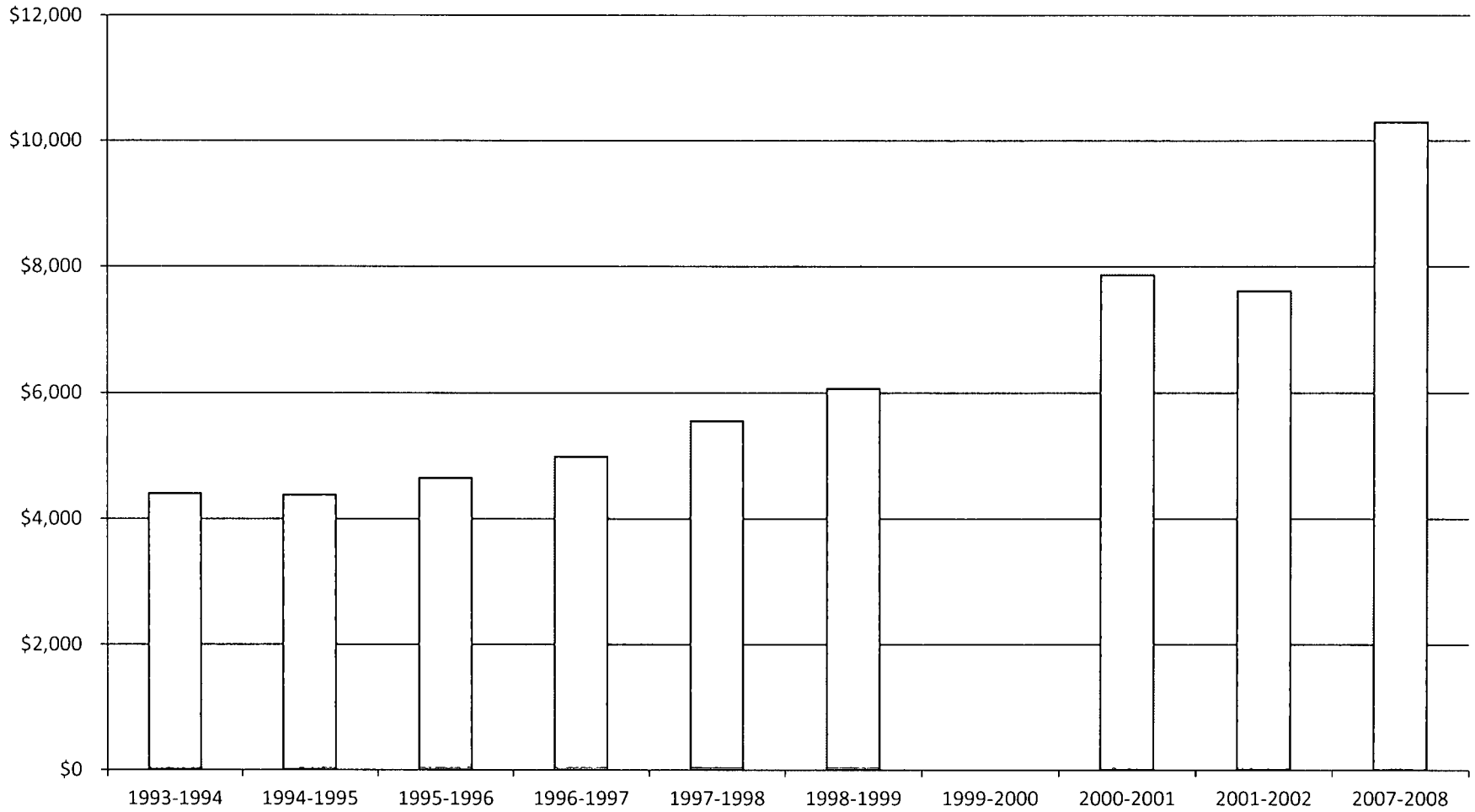

Jasper - Revenue Per Pupil from State Sources



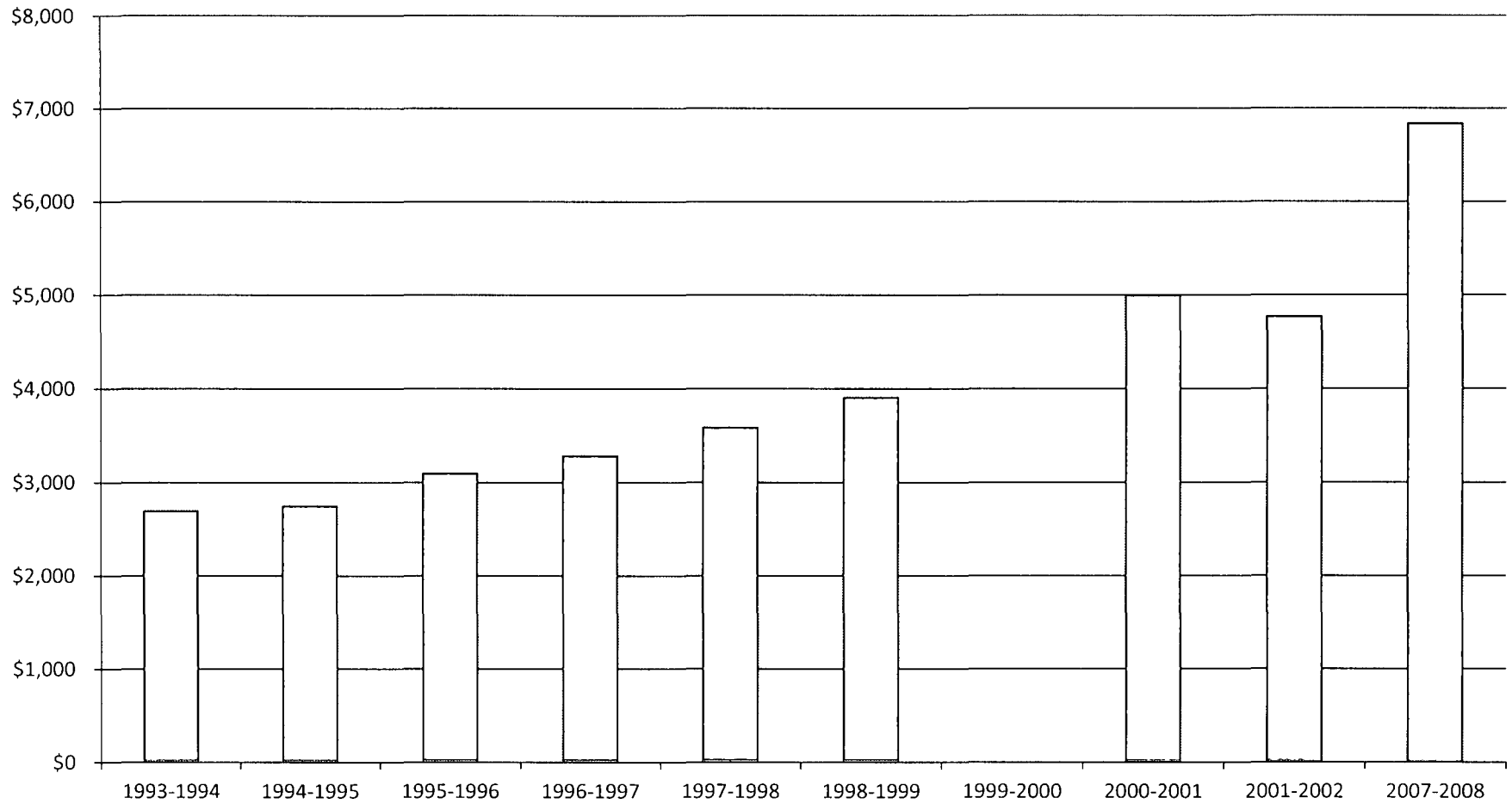

Lee - Revenue Per Pupil from State, Local, and Federal Sources



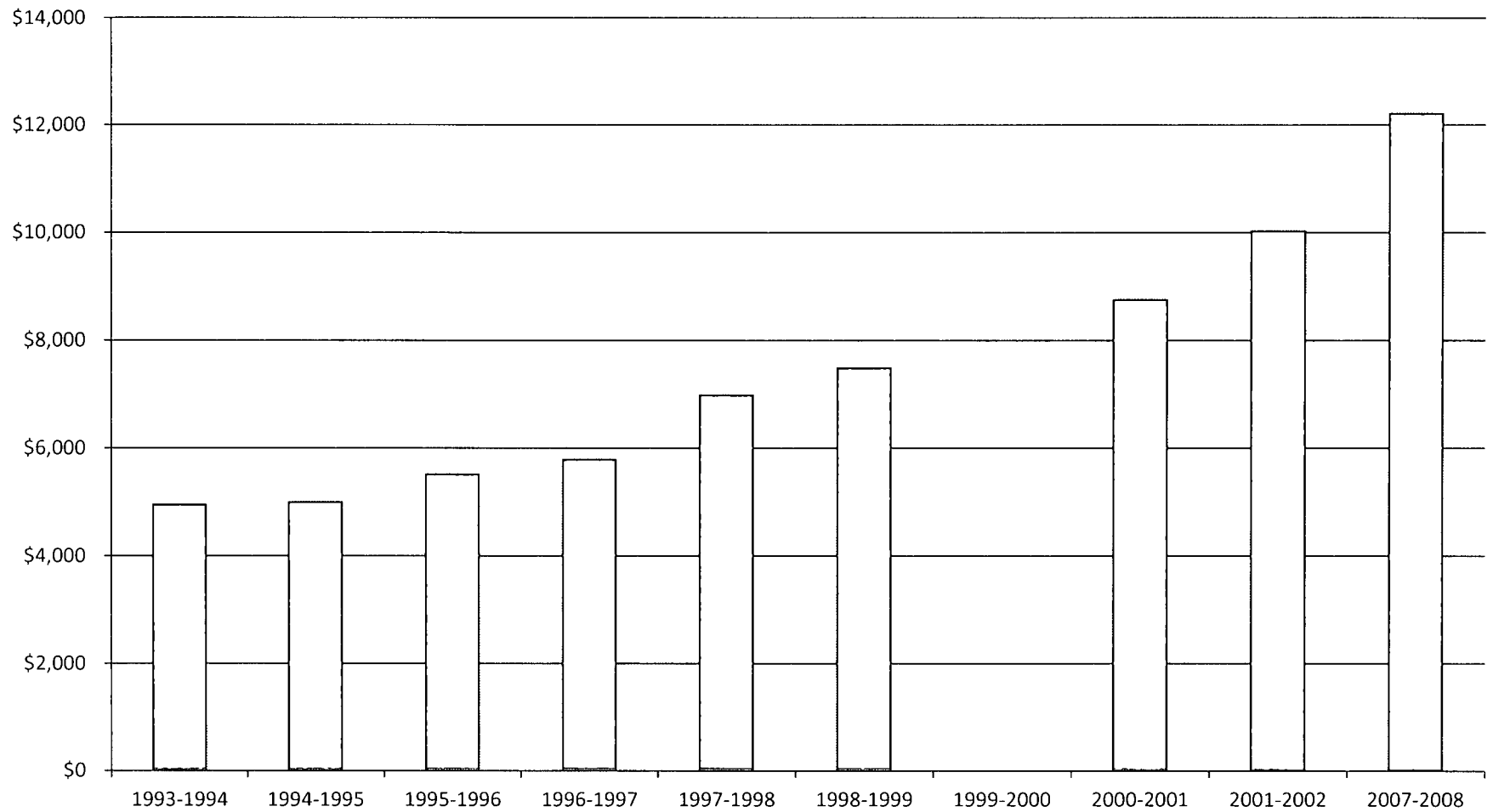

Lee - Revenue Per Pupil from State Sources



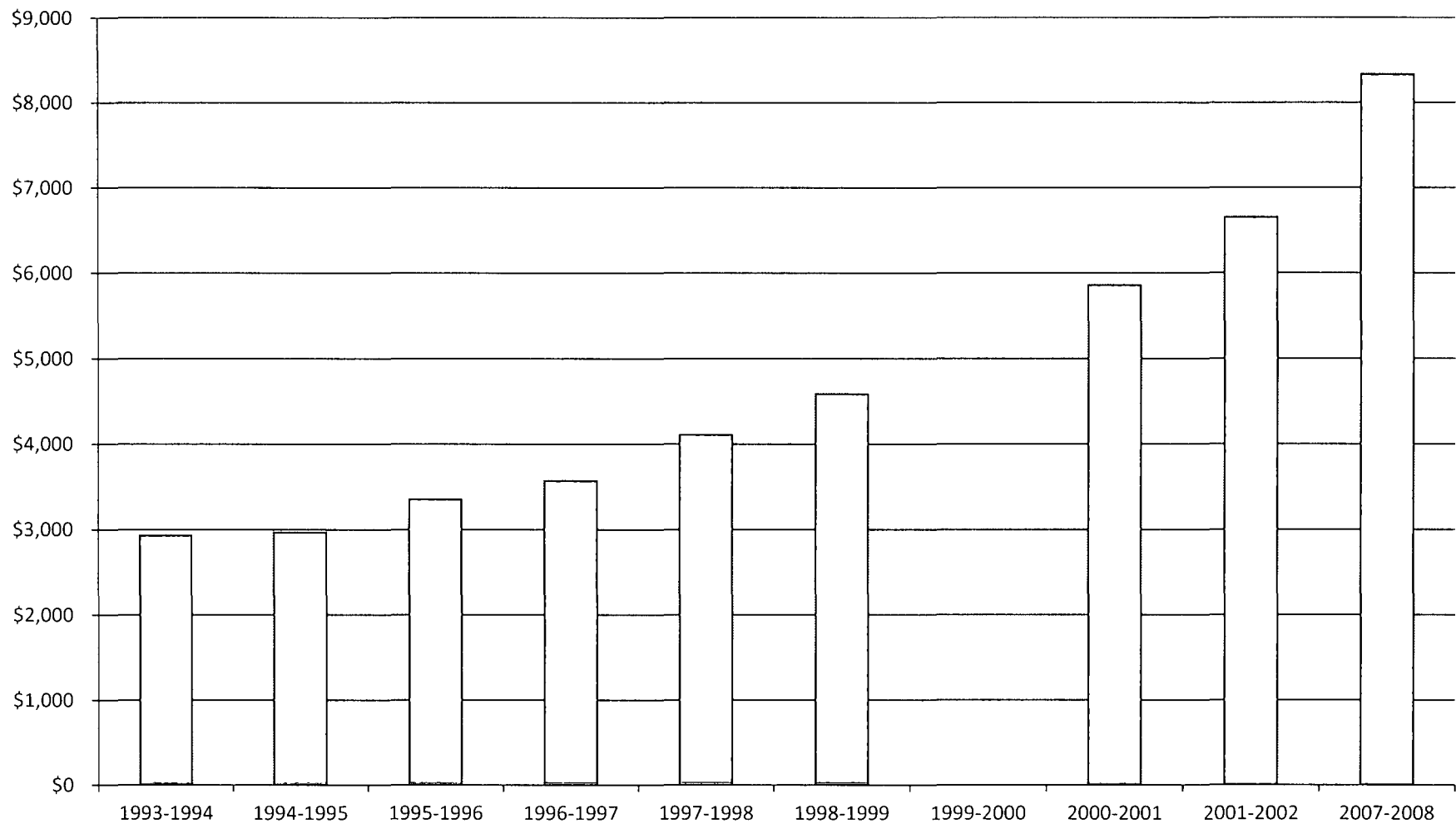

Marion 7 - Revenue Per Pupil from State, Local, and Federal Sources



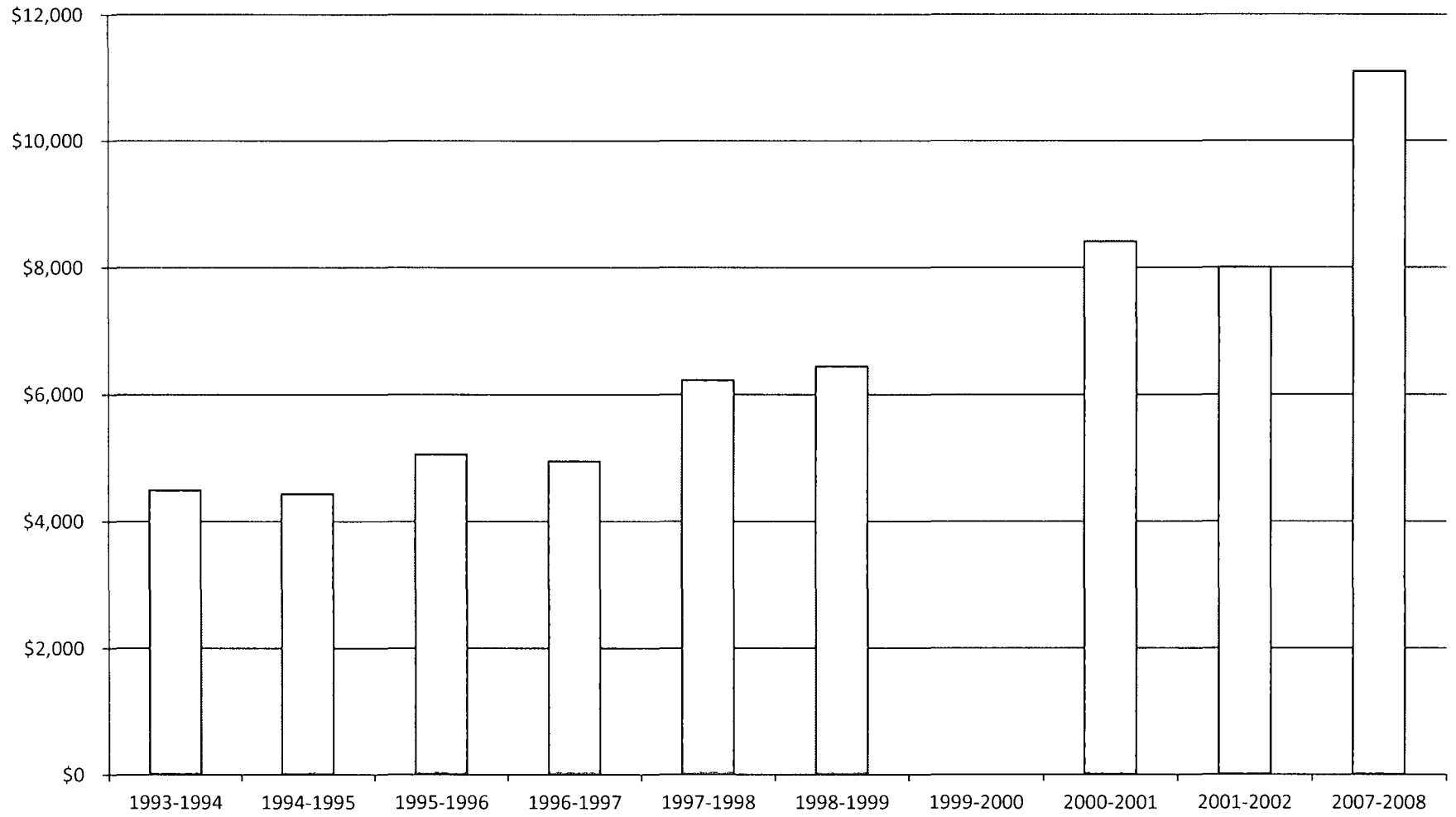

Marion 7 - Revenue Per Pupil from State Sources



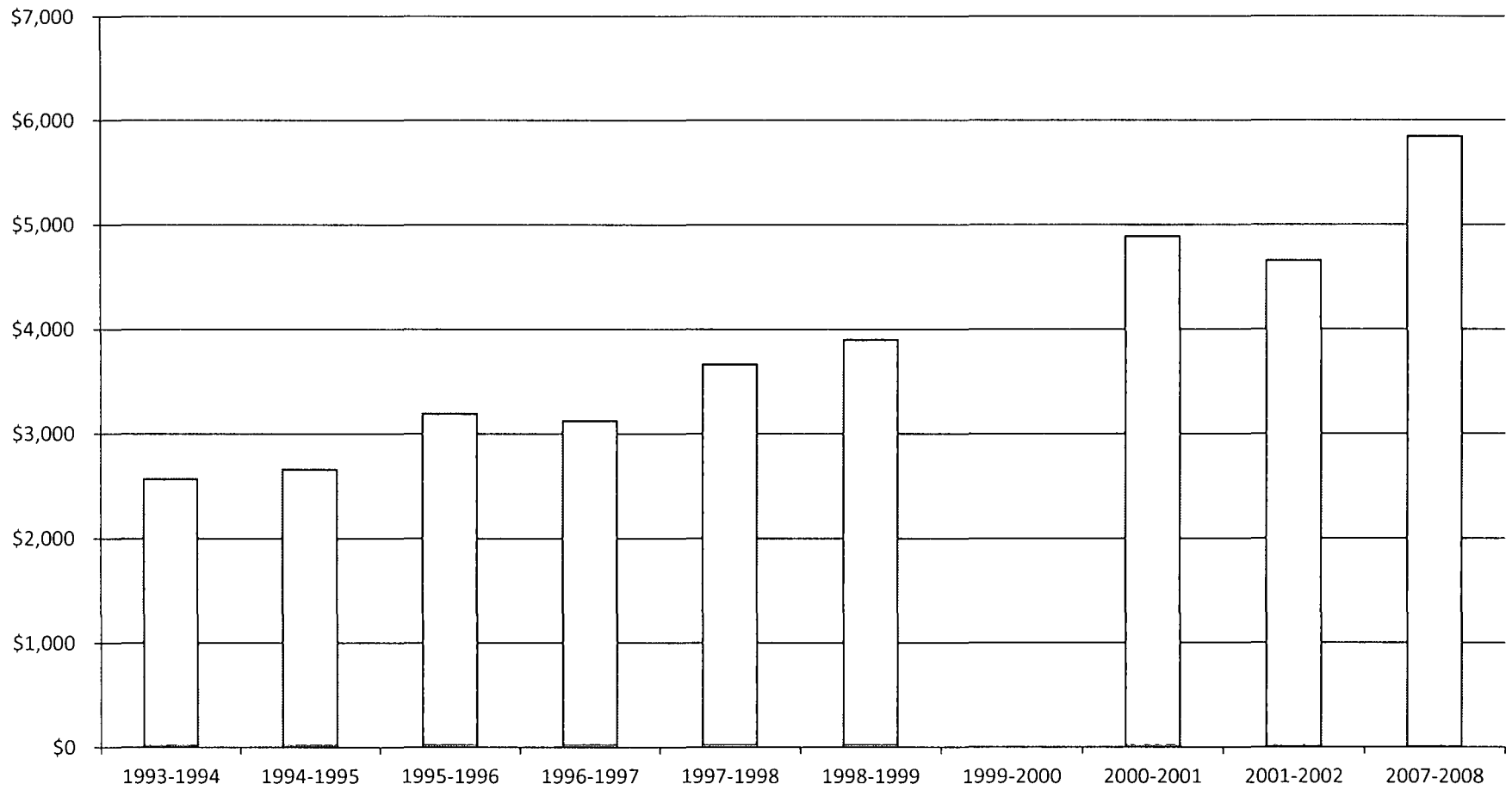

Orangeburg 3 - Revenue Per Pupil from State, Local, and Federal Sources



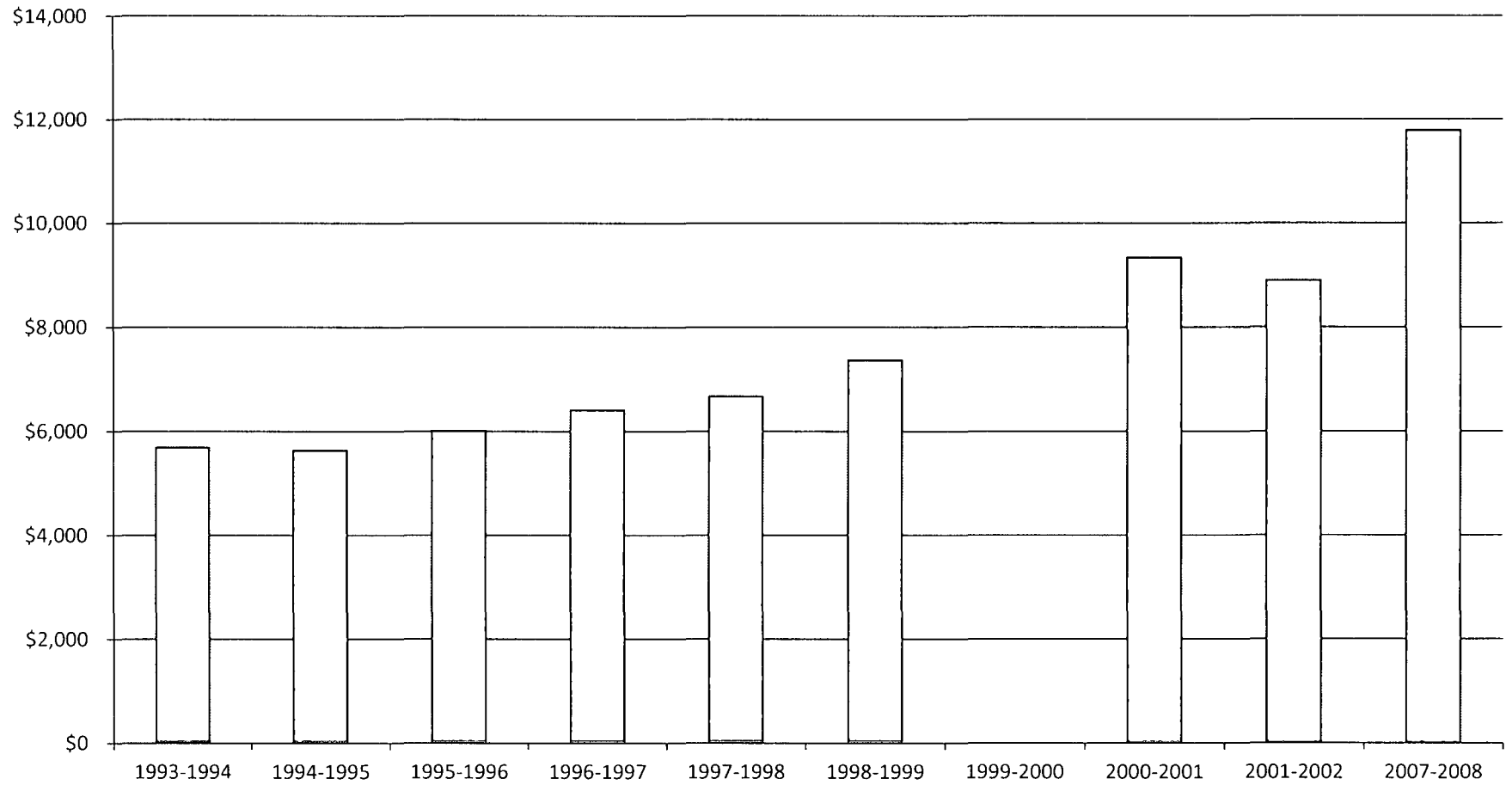

Orangeburg 3- Revenue Per Pupil from State Sources



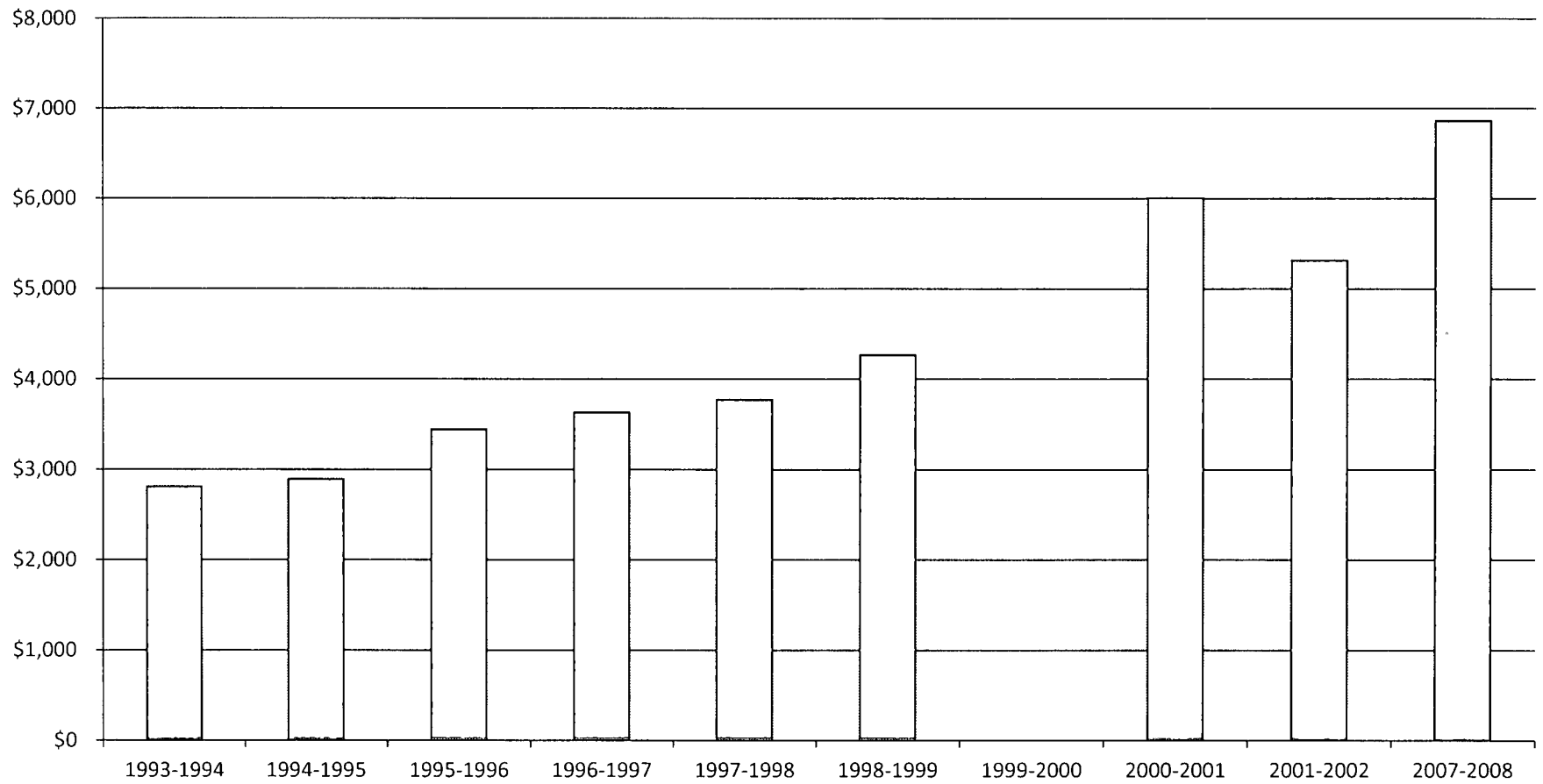
