

Appellant proposes the following be included in the Record on Appeal:

- (1) True-billed indictment;
- (2) Trial Transcript pages 1 – 3 and 45 – 158;
- (3) State's Ex. 1B, 2G (To be transported with the following caveat—The disks entered into evidence unfortunately contain media files that were not admitted into evidence in this case, as indicated in transcript pages 41-44 and confirmed by counsel's communication with the clerk of court. Appellant is **not** designating those items which were not entered into evidence but are contained on the disks which are in the clerk of court's possession. Counsel for appellant has brought this problem with the clerk's evidence to the attention of the Attorney General. The Attorney General indicated a willingness to ensure that only what was actually entered into evidence will be placed into this Court's record; however, the Attorney General obviously cannot make a final decision on such a matter until it has had a full opportunity to review the case and complete its own investigation. Counsel fully expects that the parties will be able to solve this problem without intervention by the Court.)


