TO BE INCLUDED IN APPEAL**





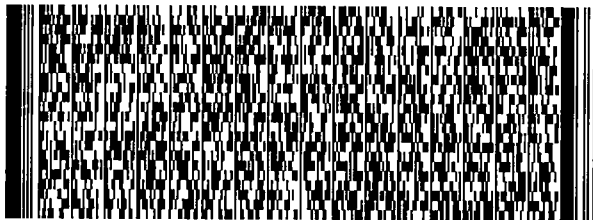
