ORDER AMENDING SENTENCE


This matter comes before the Court by way of Defendant's Motion to Reconsider Sentence, filed on December 7, 2017. Defendant Samuel Broadway was tried and convicted on the above-referenced charge before the Honorable R. Markley Dennis, Jr., and sentenced to a term of imprisonment of twelve (12) years.

Upon consideration of the Defendant's Motion, and the arguments presented at the hearing held on the Defendant's motion on September 28, 2017, the Court finds good cause to amend the sentence.

Accordingly, the Defendant's Motion is hereby **GRANTED**, and the Defendant's sentence is hereby amended as follows:

**The Defendant is sentenced to 18 years, suspended upon the service of 8 years. The Defendant shall be given credit for all time served prior to this Order, as calculated by the Department of Corrections.**

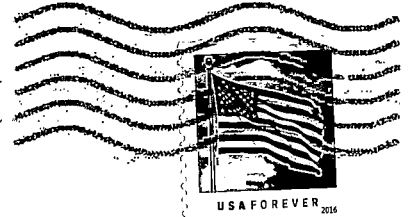
