
MOTION FOR COSTS

Pursuant to Rule 222, SCACR, Respondent Todd Bullman, as Personal Representative of the Estate of Caitlin Bullman, requests that the costs of this appeal be taxed against Appellant Charlotte-Mecklenburg Authority. Rule 222(a) provides that, unless the Court orders otherwise, “costs shall be taxed against the appellant when the . . . judgment on appeal is affirmed.” Rule 222(a), SCACR. This Court dismissed the appeal on December 28, 2017, and the Remittitur was issued on January 16, 2018. Because the Court has not ordered otherwise and because the parties

have not agreed otherwise, Rule 222 provides the Court should award costs to Respondent Todd Bullman.
