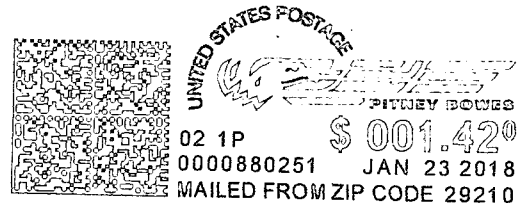
DEAR MS. KITCHINGS:
