
Dear Mrs. Moffitt:

I agree to pay the per page charge for this transcript as provided by Rule 607, SCACR.

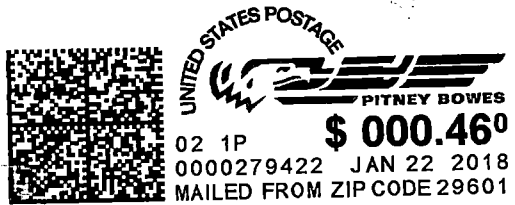
