
I was appointed to represent Mr. Terrance Bland in Greenwood County pursuant to indictments 2016-GS-24-00675; -00676; -00677; -00678; -00682; -00683; and 2017-GS-24-01930. On or about November 9, 2017, Judge William P. Keesley imposed sentences upon his conviction on each indictment. Pursuant to Mr. Bland's request, I filed a notice of appeal with the SC Court of Appeals.
