

NOTICE OF INTENT TO APPEAL

On January 16, 2018, in Barnwell, South Carolina, Barrington Grant pled guilty to Unlawful Possession of a Firearm by a Person Convicted of a Violent Felony (2 counts) and Unlawful Possession of a Stolen Pistol before Judge William P. Keesley.

At the time of the plea, Barrington Grant was on probation for his conviction of Assault and Battery of a High and Aggravated Nature on July 7, 2014 in Allendale County. Judge Keesley found him to be in willful violation of his probation and revoked 15 years.

Barrington Grant is appealing his guilty plea, conviction and sentence. He also appeals the Judge's finding of willful violations and the revocation of the probation sentence.

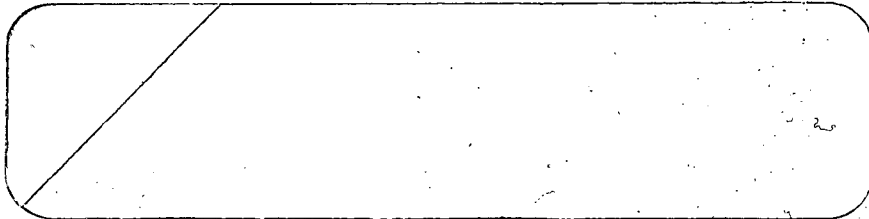

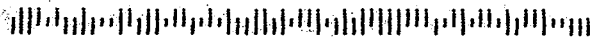
