



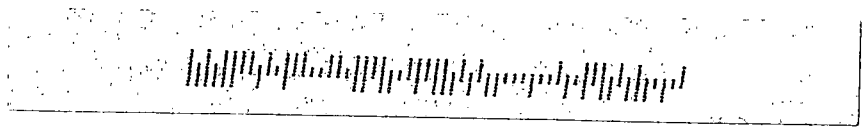
I am responding to your letter of January 23, 2018 regarding my motion to withdraw as counsel for appellant Kenneth Smith.
