This matter is before the Court on January 3rd, 2018, upon duly filed and served Motion for Reconsideration by Attorney Delton W. Powers, Jr., on behalf of the Defendant. Immediately prior to the hearing on this Motion, the Court heard and granted the Defendant's counsels' motion to be relieved. As to this matter, the Defendant is appearing before the Court pro se.

Defendant Glover informed the Court that although he entered an *Alford* plea, he had wanted the jury to hear his side of the case and thought that they still would. The Court in reviewing the matter and in questioning Mr. Glover determines that the plea was properly presented, that the Court in fact asked all the questions that were presented in his signed plea affidavit, and there are no grounds to reconsider the sentence on his behalf. His Motion for Reconsideration is hereby denied.

The Prosecutor asked that upon this Motion Defendant Glover's sentence be increased; the Court would deny that request as well.


IT IS THEREFORE ORDERED, ADJUDGED and DECREED:

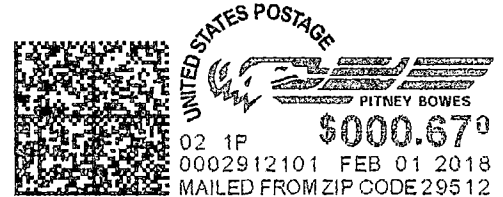
