
AFFIDAVIT OF FACTS GIVING JUDICIAL NOTICE; AND
MOTION TO MOTION THEREFOR

TO: THE S.C. SUPREME COURT ET. AL.,

THE ATTORNEY GENERAL TO THE (4) GLOBAL THRONES GIVE THE COURT AND PARTIES JUDICIAL NOTICE. THE RESPONDENT IN THIS CASE IN HIS EGREGIOUS ACTS OF ABUSE OF COURT AND CONTEMPT FOR JUDICIAL PROCESS, IS STILL CONSPIRING IN ACTS OF STATE INTERFERENCE INVOLVING THE S.C. DEPT. OF CORRECTIONS. THEY ARE STILL HINDERING AND OR IMPEDING, IN ACTS OF OBSTRUCTION OF JUSTICE, OUR ABILITY TO FILE CRUCIAL COURT DOCUMENTS NEEDED TO BE FILED IN OPPOSITION TO THE RESPONDENT'S MOTION TO DISMISS THIS CASE.

WE OBJECT. LAST WEEK THEY WERE SELECTIVE IN THEIR COPYING AND ONLY COPIED ABOUT (2) OF THE DOCUMENTS NEEDED TO BE FILED INFORMING US THAT THEY WOULD MAKE COPIES OF THE REMAINDER OF THE DOCUMENTS SOUGHT FILED ON FEBRUARY 1, 2018. THAT DATE CAME AND THEY ONLY MADE ONE COPY OF A PARTICULAR DOCUMENT WE SOUGHT COPIED OMITTING (5) PAGES CREATING AN INABILITY FOR US TO SEND THIS ONE DOCUMENT INTO THE COURT, DUE TO IT BEING AN INCOMPLETE DOCUMENT. WE WERE THEN INFORMED BY OFFICER MEGGETT THAT WE HAD TO WAIT UNTIL FEBRUARY 8, 2018 JUST TO GET COPIED THE (5) PAGES SHE OMITTED AND TO POTENTIALLY HAVE THE OTHER DOCUMENTS WE SOUGHT COPIED DONE WHEREUPON THEY WOULD BE SENT TO THE COURT. OFFICER MEGGETT HAS REPEATEDLY WORKED WITH THE RESPONDENT IN EFFORTS TO IMPEDE, HINDER AND OBSTRUCT US IN BEING IN COMPLIANCE TO THE DEMANDS OF THE COURT WHICH IS WHY THE INJUNCTION IS ALSO SOUGHT BEFORE THIS COURT. I GIVE THE COURT NOTICE THAT DUE TO THIS CONTINUAL STATE INTERFERENCE WHICH THE RESPONDENT HAS CONSISTENTLY INVOLVED HIMSELF IN. I DO NOT WAIVE THE RIGHT TO HAVE THESE DOCUMENTS SUBMITTED AND REVIEWED BY THE S.C. SUPREME COURT AS IT PERTAINS TO THESE EXHIBITS, BEFORE ANY DETERMINATION IS MADE WITHIN THIS CASE.
