TRAFFICKING COCAINE

The defendant, Ashley Nicole Cox, did on or about January 1, 2017, in York County, South Carolina, knowingly sell, manufacture, cultivate, deliver, purchase, or bring into this State, or did provide financial assistance or otherwise aid, abet, attempt, or conspire to sell, manufacture, cultivate, deliver, purchase, or bring into this State, or was knowingly in actual or constructive possession or knowingly attempted to become in actual or constructive possession of ten (10) grams or more of cocaine or any mixtures containing cocaine, as provided in 44-53-210(b)(4), all in violation of Section 44-53-370(e), Code of Laws of South Carolina (1976, as amended).
