Pursuant to Rule 212(b) counsel for Appellant Jacob Daniel Drotning respectfully requests to supplement the Record on Appeal, pursuant to Rules 210(c) and (f), and Rule 212(b) of the South Carolina Appellate Court Rules. In support of this motion counsel shows the following:

1. The Initial Brief of Appellant and Designation of Matter to be included in the Record on Appeal was served and filed on September 6, 2017.
2. The Initial Brief of Respondent and Designation of Matter to be included in the Record on Appeal was served and filed on December 28, 2017.
3. During the preparation of the Final Brief of Appellant it has come to counsel's attention that the indictments were included in the designation of matter but inadvertently omitted from the Record on Appeal.




