Jurors of Oconee County present upon their oath:

CRIMINAL DOMESTIC VIOLENCE OF A HIGH AND AGGRAVATED NATURE

That defendant, Jacob Daniel Drotning did in Oconee County, South Carolina on or about May 16, 2014, cause, offer, or attempt to cause physical harm or injury to Catherine Cook, a household member of the Defendant, with the present ability under the circumstances reasonably creating fear or imminent peril and Jacob Daniel Drotning intentionally committed an assault and battery which involved the use of a deadly weapon, or resulted in serious bodily injury, and/or an assault, with or without an accompanying battery, which would reasonably cause fear of imminent serious bodily injury or death, to wit: defendant did light the victim on fire using gasoline causing burns over 60% of her body. All in violation of 16-25-0065, Code of Laws of South Carolina, (1976), as amended.
