This matter comes before the Court on a motion to reconsider sentence on indictment numbers by the Defendant (2015GS3202805; 2015GS3202815; 2015GS3202807; 2015GS3202812; 2015GS3202813). On April 05, 2016, Mr. Stroman pled guilty to the aforementioned indictments and sentenced to the South Carolina Department of Corrections, as follows: 30 years per indictment (3) counts of Kidnapping (2015GS3202807; 2015GS3202812; 2015GS3202813 – all concurrent with remaining indictments); 20 years on (1) count of Armed Robbery (2015GS3202805; consecutive to 2015GS3202815); 30 years on (1) count of Armed Robbery (2015GS3202815; consecutive with 2015GS3202805) with credit for time served of 224 days of pre-trial detention at the Lexington County Detention Center.


A hearing on said motion was held on May 31, 2016. Present at the hearing were the Defendant and his attorney, Derrick E. Mobley. Also present was Senior Assistant Solicitor Angela Garrick Martin representing the State.


Having considered all arguments advocating for and against the originally imposed sentence, this Court grants the Defendant's motion to reconsider sentence and rules, accordingly: Indictment # 2015GS3202815 (Armed Robbery) - the Defendant's sentence is reduced from (30) thirty to (20) twenty years to be served at the South Carolina Department of Corrections.

IT IS THEREFORE ORDERED that the defendant, Sean Larmont Stroman, be sentenced to the South Carolina Department of Corrections on the following indictments: 2015GS3202807 – 30 years; 2015GS3202812 – 30 years; 2015GS3202813 – 30 years; 2015GS3202805 – 20 years; 2015GS3202815 – 20 years; all to be run concurrent. All aspects of the prior sentences remain the same.

IT IS ALSO ORDERED that the South Carolina Department of Corrections shall update Mr. Sean Larmont Stroman's sentence accordingly.

IT IS SO ORDERED this 20 day of June, 2017, at Lexington, South Carolina.

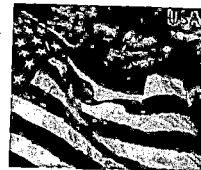
