
**Subject: Notice of Appeal – Filing Error**

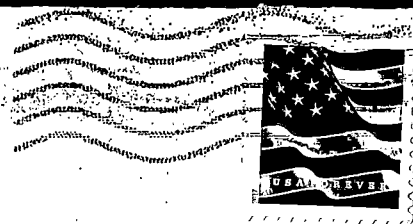
