

appeal, with each party bearing its own costs.



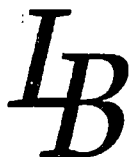



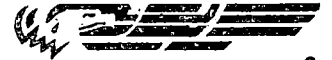
