I sent the letter on February 2nd, and will send Ms. Harris a copy of this letter as well.

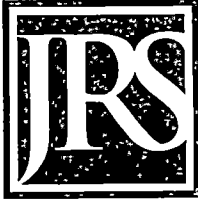

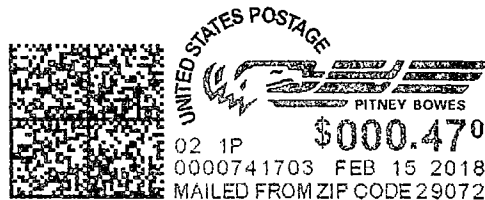
