

5. Counsel has spoken with counsel for the State who does not oppose this request.



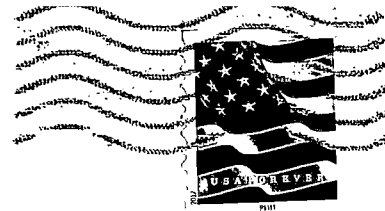
