

NOTICE OF APPEAL

Andrew Allston Kirkland appeals his conviction and sentence in the above captioned case. Appellant was tried by jury in the Charleston County Court of General Sessions beginning February 5, 2018. On February 7, 2018 the jury found the Appellant guilty of criminal sexual conduct – third degree. Immediately following the jury’s verdict on February 7, 2018, The Honorable Kristi Lea Harrington imposed a sentence on the Appellant. Additionally, on February 7, 2018, the Appellant made a Motion for New Trial which was subsequently denied.

This Notice of Intent to Appeal follows. Appellant’s trial defense counsel would note that they are filing this Notice of Appeal; however, counsel believes that Appellant may now qualify for counsel through the Office of Indigent Defense. 




