TO: THE HONORABLE JUDGES OF THE SOUTH CAROLINA COURT OF APPEALS

COMES NOW the Respondent, Yuasa Exide, Inc., by and through undersigned counsel, pursuant to Rule 263(b), SCACR, and moves this Honorable Court for an extension of twenty (20) days' time to file/serve the Final Brief of Respondent *after service of the proper and complete Record on Appeal*.

The Appellant served the Record on Appeal on January 31, 2018, thereby, making the Respondent's final briefing deadline February 20, 2018, according to Rule 11, SCACR. Upon receipt of the Record on Appeal, the undersigned noted that it did not comply with Rule 210, SCACR, in many aspects. First, the pages of the Record on Appeal were not consecutively numbered. Second, numerous items which the Respondent designated for inclusion in the Record on Appeal were omitted. Third, certain items included in the Record on Appeal had handwritten notes which were not presented to the court below, that is, to the Workers' Compensation Commission. As such, on February 9, 2018, the undersigned noted these issues in a letter to the Appellant and via email provided copies of the missing documents or clean versions of the designated documents. On February 13, 2018, the undersigned spoke with the Appellant about the February 9 correspondence and the compilation of the Record on Appeal. As of the date of this filing, the undersigned has not received a supplemental or replacement Record on Appeal. As such, the Respondent is unable to prepare its Final Brief.


The undersigned has consulted with the Appellant counsel before filing this motion, as noted by Exhibit A.
