

CONSENT MOTION FOR EXTENSION





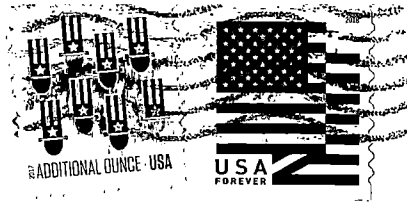
