Dr. Van was a plant by the defense attorney to make it look as my shoulder was a strain and not what the MRI said. Dr. Van never looked at my MRI and he sent me for a second xray. I asked for a second opinion and it took me three months to get it. George Gallagher would unlawfully stop my checks to get other information out of me concerning my disability, which in my opinion is bullying. George Gallagher and former attorney Ryan Montgomery sent me an email stating that no one would see me not even Dr. Paylor. I asked Dr. Paylor if that was true and he said he would love to treat me and do my surgery. Therefore, George Gallagher lied and Ryan Montgomery saying that Dr. Paylor would not see me for my a second opinion. Workers Comp stopped my checks to force me to go back to Dr. Van. Also on page 2 of the order, I went to see Dr. Pommeranke at Doctors Care. He first gave me pain meds and referred me to physical therapy. Realizing I was in to much pain, Dr. Pommeranke removed me from physical therapy and ordered me to go get an MRI done to my shoulder. We spoke briefly about the sourness to my back. He was hoping that it was just formally the lifting I've done. I went for my MRI and went back for my follow up where we went over the MRI. Dr. Pommeranke felt like I needed to have surgery done to my left shoulder and felt it's best that I go back to Dr. Paylor so this doesn't fall through the cracks. That's when Workers Comp sent me to Dr. Van instead of Dr. Paylor. Dr. Van was apart of throwing me under the bus with George Gallagher.

On Page 3 of the order, Attorney John Holland and Usry was released by Nathaniel Alston for the basic of Dr. Keith was doing the same thing Dr. Van was trying to do, make it look like I didn't need surgery. I told Dr. Keith that my back was hurting and has been for over three months. He examined my shoulder, neck, and lower back and lumbar area. For some reason, he did not include my back in his notes. He seemed to think the problem was my neck and I told him it's m back. I showed him a list of my medications I'm taking and needed refilled, he said he don't write pain meds. I went back to have an office visit to talk to him letting him know that this is a surgical matter and asked if he could do my surgery and why he couldn't refill my prescriptions. I recorded our last visit and would like to put my recording of our talk as evidence. Dr. Keith tried to make me look like a junky for pills and said that I was upset. Which is not true.

I would like to have all my MRIs submitted in as evidence and also all medical. I also would like to be reimbursed for all my medical, medication, and surgery into the claim. I had my surgery done by Dr. Paylor on November 10, 2017. I paid for it myself and I would like to have it submitted in as evidence. My wife is a witness.
