
Robert M Cox appeals the order of the James B Jackson, Jr. dated November 15, 2017. Appellant did not receive written notice of entry of this order.





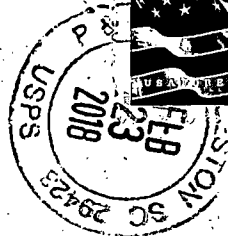
