


Should the motion be granted, please bring any filing fees necessary to my attention. They will be paid as soon as I am notified.

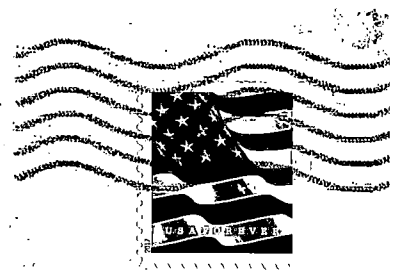
