AND SO IT IS ORDERED.





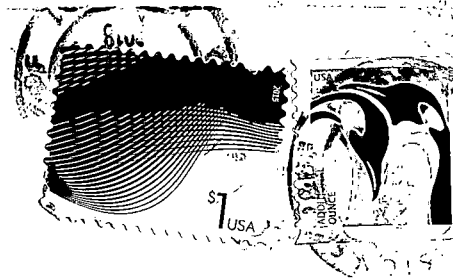
