
Gentlemen:

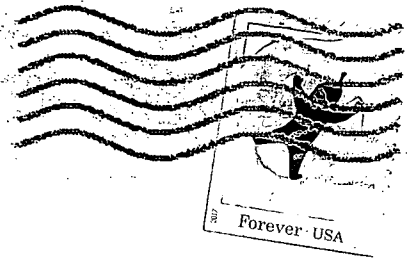
