those days in Edgefield Co. black & white  
was unheard of but if anybody know  
anything about the history of the Strom  
Family they would know that his name  
was actually "Thurmond Strom" he changed  
it around. I don't know your race  
and it doesn't matter to me but I'm  
being done wrong and you're the only  
person that I've written to and I've  
gotten results and things started to  
happening for me in my case.... I also  
asked why wasn't a 59-E filed on  
my behalf? no response, I feel I'm  
being held in prison because I hadn't  
had no representation in the 3 yrs I've  
been locked-up... Please Sir would  
have a look at my case and if  
you see any wrong that I've done  
I'll do the time and won't ever  
bother you again, I miss my mother  
my kids and my Grandkids that's  
all I want is to be back with them  
I hadn't seen any of them in 3 yrs.
