NOTICE OF APPEAL


Under SC Code 18-9-130 (A)(2), A plaintiff may not enforce a sale of property after a notice of appeal is filed without giving an undertaking or bond to the defendant, with two good sureties, in double the appraised value of the property or double the amount of the judgment, conditioned to pay all damages the defendant may sustain by reason of the sale in case the judgment is reversed.

The requirements of the above said statute must be confirmed and verified by the Clerk of Court of Appeals prior to any sale of the defendant's property.
