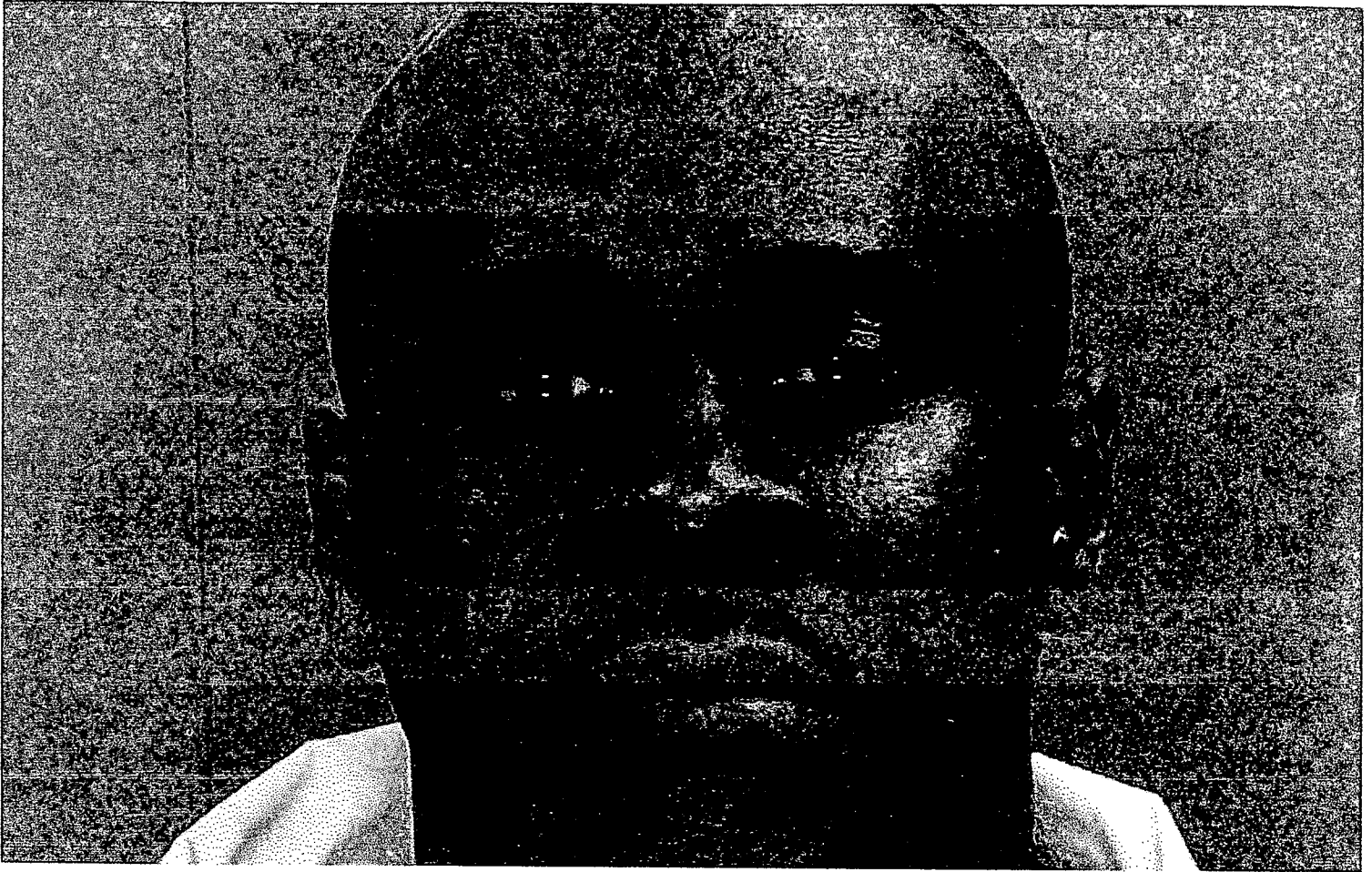

Dear Sir/Madam of the Appeal

I am writing in hope and prayer that you will consider my concern for my life and my freedom. I have a pending charge from 2014 of CSC 1st degree for allegedly molesting my daughter. Your Honor the Department of Children and Family brought the charges against me in 2014. I sat in jail for 8 months before they decided they wanted to take me in front a judge to be put on sex offender registry and the family court judge ruled that they did not have sufficient evidence proving I committed this crime. After, DSS couldn't prove their case against me, it was closed and the state picked it up. My children's mother live in boyfriend Knott ( a\*k\*a Jamie Stroman) was arrested on another crime and that's when my daughter informed my mother that he was actually the man who hurt her. My mother advised my daughter to tell her mother and that's how Knott became a suspect. Her mother not once indicated her boyfriend to any of the authorities. A lot has changed even the first two public defender's on my case and my son being a witness for the prosecutor. When my daughter found courage to tell my mother what happen. She said her mother had her and her brother calling Jamie daddy. Your Honor, before this incident I did not seen my children by Sarah except at my mother house in Columbia, S.C. I was young and wasn't ready to settle down. I had three different girls and two of them has my child. In any event, when she told them Daddy hurt me, I immediately became number one suspect due to the lies of her mother. My daughter went for her interview at Dickerson Center, I learned her mother was in there and from my understanding this is supposed to have been a private interview to see if my daughter was coached. At the defendants(Jaime Stroman) trial my public defender and I was present at my daughter's testimony and she clearly states that me "her father" did not hurt her, but her mother's live in boyfriend Jamie Stroman did. And at the time, Sarah only has herself and our two children residing at her residence. At that time her and Jamie was involved and they lived with my grandmother prior to moving in Park North where all four resided in a three bedroom apartment. I asked my public defender would my daughter's testimony be of help to me and he told me her transcript will not be amisable for my trial. I failed them by not protecting them from this man. I chose not to fight with their mother when she chose to exclude me and let Jamie help her. I do not know this man very well, but every time I have confronted him based on what my children was telling my mother. But Sarah took me out of their lives even more if I dared talk to her about any issue concerning him and my children. I had 6 children at the time and my 7 one was to be born that following year 12/2014 and Sarah didn't like that. I grew up and took my mother's advice about becoming a grown man and became a better father to my children. At the time of my arrest I was working two jobs, realizing that I am a father and I need to help gain stability for my children as well as myself. I lost both jobs and my life because of this crime. After my mother bailed me out I was granted permission to leave state and regain some peace of mind being as I live in Florida with her. I had to leave South Carolina because I could not get a job or better my, and I lost my two oldest children. I haven't seen my daughter prior to Jamie trial in 2017 since the incident. My life has been put on hold for the last 3 in a half years. I have asked my lawyer for the new evidence, ask him to file for a motion of suppress for case to be reviewed by a judge to seek speedy trial because of man convicted, there is a different transcript from the original that my mom has, and I have laid eyes on any of my DNA to say I committed this act against my own child. I feel like my constitutional rights have been violated by the judicial system. I do not have a record that will paint me as a

monster to hurt anyone's child. As a result of my fear of Jason Choshosky fighting for me, I did try to relieve my public defender because of the fact he refused to communicate and or informed me of evidence or proof. He treated me like he knew me personally and I felt hatred from him. I just want a fair trial and not be sentenced for something that I did not do. I don't understand how they have two separate warrants with two separate time frames, and how I am a co-defendant of a man that I never hung out with or even knew. And he certainly did not reside at either of the residences I resided. My daughter states this man has been hurting her for a year and I just found that out at his trial. My daughter didn't reside at the accused crime scene which is my mother's address. She resided with her mother, my son, and live in boyfriend for over 3 yrs. She was 7 at time of incident and now she is 11. So I asked you Honorable Judge to please review all the evidence including the original discovery I have in my possessions, the Department of Social Services records, and school records for my daughter and son, they attended the same school. I do not want to spend my life in prison for a crime I didn't commit, especially my own daughter. I have made plenty mistakes, but hurting people violently isn't me, especially children. I am asking that the Appeal Courts accept my appeal and help me because this crime has devastated my whole life and my children

# 35 years in prison for man convicted of sexually abusing young girl

LEXINGTON COUNTY, SC — A man convicted of sexually abusing a young girl has been sentenced to more than three decades in prison.

Jamie L. Stroman, 38, was found guilty on Thursday in Lexington County of two counts of first-degree criminal sexual conduct with a minor. Circuit Judge Robert Hood sentenced Stroman to 35 years in prison, according to the 11th Circuit Solicitor's Office.

Stroman was arrested after the Lexington Police Department began investigating in June 2014 allegations that he had abused a girl younger than 11 years old from 2013 to 2014.

**II. DETERMINATION AND REASONS FOR AGENCY INVOLVEMENT:**

Lexington County Department of Social Services received an allegation on 03/04/14 in that: Lexington County DSS received allegations that Katelynn English (7 yrs. old) exhibited a mucous discharge from her vaginal area while at school. The reporter stated that the child's mother took her to Palmetto Health Richland for an examination. The reporter stated that the mother questioned the child while in route to the hospital, and the child told the mother that Eric English (child's father) put his nasty in her nasty.

According to the reporter, the doctor agreed that the child appears to have been sexually abused, via penile, as alleged.

DSS indicated the case for Sexual Abuse on 4/15/14. The child, Katelynn submitted to a forensic interview and made a disclosure of sexual abuse by her father, Eric English. Both Katelynn and Mr. Eric English tested positive for the STD gonorrhea. Eric English was arrested and charged with criminal sexual conduct.

**III. LEGAL HISTORY: No Convictions**

**IV. BACKGROUND INFORMATION:**

Lexington County DSS has not had prior history with this family.

**V. CURRENT SITUATION:**

Eric English is currently in Lexington County Detention Center.

**VI. RECOMMENDATIONS:**

1. The court find that Katelynn English was sexually abused as defined in § 63-7-20 by Defendant Eric English and said finding shall be entered into the DSS Central Registry of Child Abuse and Neglect.




An investigative forensic interview was conducted based on a referral from Detective Tricia Stoner of the LCSD. **The following addresses some statements made during the interview. This does not reflect all statements made. For a complete interview, agencies involved should obtain and review a copy of the DVD.**

**Katelynn reported being "scared" to talk at the beginning of the interview. She wanted her mother to be in the room. Katelynn reported that her father is "who hurt me." She reported that she would visit with him on the weekends. She stated, "Every time I go over there he does it."**  
She reported that she was 7 years old when her father "hurt" her, and her brother was 6 years old. She stated that her father would hurt her at night in the living room where she sleeps on the floor. Katelynn stated that at her father's home she, her brother, her father, and her father's girlfriend ("Amanda") all sleep in the living room on the floor and other family members sleep in the bedrooms in the home. She stated that her brother, Eric "EJ," saw her father hurting her and her father told him to "turn back around." EJ was crying because their father hit him due to him turning around and looking. He hit EJ on the chest with his hand. Katelynn stated that when her



5. This Court should order that Defendant, Eric English, be entered in the Central Registry of Child Abuse and Neglect.



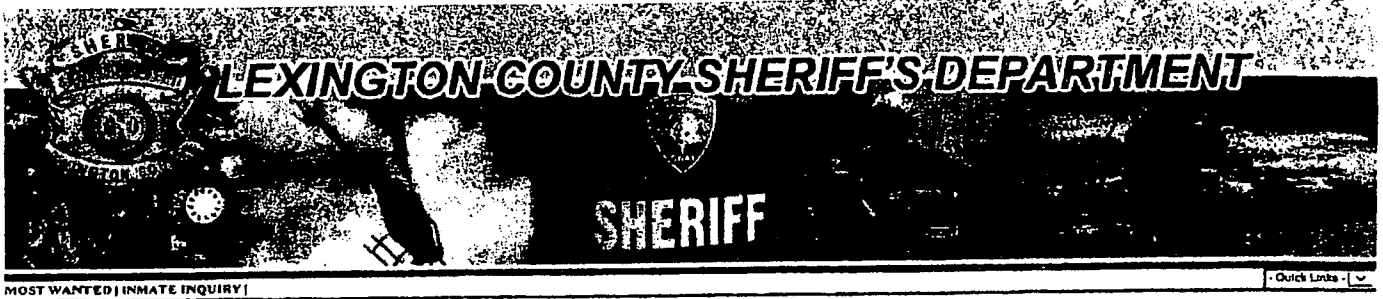

He stated that he had an attorney Alex Postic that was representing him in his Family Court case to obtain custody of his children. He started telling me about Sarah calling his family and slandering his name. He stated that everywhere he went someone approached him about this case. school. The guidance counselor had come to him and wanted me to call her so that she could let me know what Sarah had come to the school saying. Sgt. Black advised that the principle had told him that Sarah had come to the school telling them that Katelynn had gonorrhea and syphilis. He provided me with the counselors contact information. Julie Gies at [REDACTED].

I called Julie a [REDACTED] and she stated that they have been seeing red flags in reference to the boyfriend handling situations. They children have been afraid of their mothers boyfriend. Not, will spank them and discipline them when they get in trouble at school. Sarah told her once when they broke up that she felt that he was too aggressive with the children. She did not see marks or bruises on the children. She stated that she went to firehouse subs for lunch when Sarah was working and she asked her how the kids were doing at school. When she went back to the school the children were not in school that day. I advised her to contact Olivia Sinclair with LCDSS, that she was assigned this case. I also advised her that if the children told her or any staff anything that they felt concerned about that she could contact the Town of Lexington and make a report with them. She stated that she would do that.

On 03-27-2014 Alex Postic called and left a message that Eric had called him again and advised that he denies the allegations. Eric also told him that his daughter has gonorrhea and syphilis and he only has gonorrhea and that exonerates him. He also say there are several other people that are around Katelynn that have those two diseases and they should be looked at.

On 03-28-2014 I watched the forensic interview of Katelynn English done by Brooke Wymer.

When Brooke was asking about family members Katelynn told Brooke that her Daddy, Eric, was the one that hurt her and that was what they were going to talk about today.

Katelynn stated that she spends the weekends with her father and does spend the night. She does not go anymore. She said that "every time I go over there he does it." She was reluctant to tell Brooke what she meant. When asked, Katelynn wanted her mother to be in the room. Brooke asked her why she was scared. She said her dad made her scared and that she just didn't want to talk about without her mom in the room. She is scared that her daddy would hurt her and isn't scared if her mom is in the room. Brooke asked if her dad ever told her that he would hurt her and she said yes. Her dad would tell her that if she told someone that he would beat her. Brooke reassured Katelynn that her dad was not there and that she was safe while she was there.

Brooke asked her about what her dad did and at what age. Katelynn said she was 7 and that it happened every weekend that she would go over there. It would happen at his house in the living room at night. She sleeps on the floor in the

living room with her dad, his girlfriend, Amanda and her brother, E.J. E.J. heard dad and turned around. Eric told him to turn back around and hit him and E.J. cried. Eric hit E.J. in the chest with his hand because he turned around and saw Eric hurting her. Amanda was not there when this happened. It was a Saturday night and Amanda was with her mom at her Aunts house for a birthday party.

Brooke asked her what part of her body her dad hurt. Katelynn pointed to her vagina. Katelynn called her vagina her nasty part. He hurt her nasty part with his nasty part.

Brooke then had Katelynn label what she called the nasty part on the boy and girl drawing. Katelynn circled the vagina and penis as nasty parts.

Katelynn said her clothes were off, that he pulled them down when she was sleeping. They were both laying down on their sides. He was behind her. Katelynn described that Eric had his hand on his nasty part and showed Brooke by moving her hand up and down that he did that on her nasty part. His nasty part was inside her nasty part. She said that it had "yucky stuff in it and it got all over me." The yucky stuff was yellow and got on her nasty part and came from his nasty part. He wiped her nasty part off with something white. She thought it might have been a sock then he would wash it. This happened more than one time. When he put his nasty part in her nasty part it hurt. It felt like he was hurting her with his fingers. She knew that it was not his fingers because she asked him what he was doing and he told her that he was "sticking my nasty part at you." She told Brooke that she was unable to get the penis inside the girls vagina.

Katelynn said that there are several people that live at Eric's house. Her nana and nanas boyfriend live there and sleep in the same bedroom. Her nanas dad lives there and has his own room. Amanda and Eric live there and sleep in the living room.

Brooke went over with Katelynn who told if this ever happened again and concluded the interview.

I obtained warrant number 2014A3210200486 for CSC with a minor 1st degree on Eric English from Judge Reinhart. The warrant was given to warrant division.

I advised Det. G. Justice of the warrant.

Det. G. Justice called and advised that he had arrested Eric English and that Eric wanted to speak with me. I advised him to let me know when he arrived at LCSD with him.

Det. Justice brought Eric to an interview room and Det. Barr and I spoke with Eric. At 1136 I read Eric his Advise of Rights from the LCSD form. He signed both sections stating that he understood his rights and agreed to speak with me.

The first thing that Eric stated was that he was afraid that he was going to lose his job at Walter P. Rawl that he had just started yesterday. I said he should be more worried about what he was charged with. He then stated that he was and that he didn't do this. He explained that a few weeks ago he worked on Friday night at Wendys. He said he lost that job because of this. Sarah came over Saturday night and asked him if her would watch EJ and Katelynn while she went out with Amanda. They left and he and Katelynn walked to his grandfathers house nearby while EJ stayed at the house. When they came home the kids watched a movie on the living room. They layed in front of the TV on the floor and fell asleep. That is where the kids sleep when they come over. He Amanda sleep in the living room under what he described as the bar that you can eat off of. There is no furniture in the living room. They woke up the next day and he played with the kids and they did not act like anything was wrong. Later that day when Sarah and her boyfriend "not" came to pick the kids up Katelynn did not want to go because of "not." He was not the son when the kids were picked up but his mother told him what happened. The kids told his mother that "not" is mean to them and makes them stand in the corner.

I asked him why he thought that the incident occurred on Saturday night. He stated that his mother told him.

He stated that he spoke with the Guidance Counselor at Katelynns school and she told him that Katelynn had "gun" on her underwear. He told her he didn't know about female things and to call her mother. She stated that if he did something to her on Saturday night how did she still have something in her under ware on Monday or Tuesday.

I advised him to tell about what he did to Katelynn. He said that he did not do anything to her, he has his kids and has a bond with them.

**SUMMARY OF INTERVIEW**

An investigative forensic interview was conducted based on a referral from Detective Tricia Stoner of the LCSD. The following addresses some statements made during the interview. This does not reflect all statements made. For a complete interview, agencies involved should obtain and review a copy of the DVD.

Katelynn reported being "scared" to talk at the beginning of the interview. She wanted her mother to be in the room. Katelynn reported that her father is "whore" and "be." She reported that she would visit with him on the weekends. She stated, "Every time I go over there he does it." She reported that she was 7 years old when her father "hurt" her, and her brother was 7 years old. She stated that her father would hurt her at night in the living room where she sleeps on the floor. Katelynn stated that at her father's home she, her brother, her father, and her father's girlfriend ("Amanda") all sleep in the living room on the floor and other family members sleep in the bedrooms in the home. She stated that her brother, Eric "EJ," saw her father hurting her and her father told him to "turn back around." EJ was crying because their father hit him due to him turning around and looking. He hit EJ on the chest with his hand. Katelynn stated that when her

father hurt her, Amanda was not home. It was a Saturday night, and Amanda had gone out with her mother, Sarah, for a birthday party. Katelynn reported that her father hurt her "nasty part." She identified the "nasty part" as the female genitals on the female anatomical drawing. She said he hurt her "nasty part" with his "nasty part," which she identified as the male genitals on the male anatomical drawing. She stated that her father pulled her clothes off while she was sleeping. He put his hand on his "nasty part" and did "this" made motion with her hands (see video) to her "nasty part." She stated that his "nasty part" was on the inside of her "nasty part." They were lying down. Katelynn was on her side, and her father was behind her. She stated that it felt like her father was hurting her with his "fingers, but he wasn't." She stated that he told her he was not and that he was 'sticking my nasty part at you.' Katelynn reported that her father's "nasty part" had "yucky stuff" in it, and it got "all over" her. She stated that the stuff was yellow. Her father wiped her "nasty part" with something white after. She believed the white thing may have been a sock because their rags are blue. She stated that he washed the white thing afterward. Katelynn reported that her father also washed the blankets afterward because the "yellow stuff" got on the blankets. Katelynn reported that she saw her father's "nasty part" and it "looked like it was leaking" and "stuff was coming out." She stated that her father was doing "this" (moving her hand up and down - see video) to his "nasty part." She stated that his "nasty part" is black. Her father told her that if she told, he would beat her. This incident was the last time she remembered this happening. Katelynn stated that this has happened more than one time. EJ saw this happening one time. She stated that Amanda was never been there when this happened.

Katelynn reported that in the living room there is a television. It was on during the incident, and Eric was watching "The Fox and the Hound" when the above incident occurred.

Katelynn reported that the "yellow stuff" was coming out of her because of her father, and she had to go to the doctor.

Katelynn demonstrated her father putting his "nasty part" inside of her "nasty part" using the anatomical dolls (see video).

*As cited in the Sorenson and Snow article, "How Children Tell: The Process of Disclosure in Child Sexual Abuse, 70 Child Welfare 1 (1991), as well as other scholarly articles, the disclosure of abuse is a process, which made include delayed reporting of abuse. The forensic interview may not reflect a complete depiction of the allegations due to this process.*

*The following recommendations are subject to change should the interviewer receive additional information/further information.*

1. Katelynn should have no contact with her father Eric English, Sr., pending the LE and DSS investigation.
2. It would be beneficial for Katelynn's brother, Eric English, Jr., to be forensically interviewed as a potential witness/victim.
3. It was stated by Katelynn's mother, Sarah Stoudemayer, that she was told that another one of Eric's children, Christopher Westbrook, may also be a victim of abuse by Eric English, Sr. He should be identified to LE and DSS and forensically interviewed.

Katelynn English reported that her father "put his nasty part in her nasty part" and he threatened to "whip" her if she told anyone. It was reported that this incident happened between 3/2/14 and 3/3/14 while Katelynn was staying at her father's house during a prearranged visit. She later disclosed that it has happened more than once. Katelynn received a SANE exam at Richland Memorial Hospital, where she tested positive for gonorrhea and syphilis.

Testing done in the ER included a urine sample which was positive for gonorrhea, and a rectal swab, which was positive for gonorrhea. A vaginal swab was not obtained. RPR was weakly reactive at 1:1, and treponemal antibody negative at <0.10. Mother reports that child received penicillin and another antibiotic at Brookland Pediatrics to treat her infections. Mother reports Katelynn's discharge resolved about twenty-four hours later.

Mother was tested for STDs in January, as part of her routine care and Pap smear, and she was negative. She denies personal sexual contact with the suspect since she was tested.

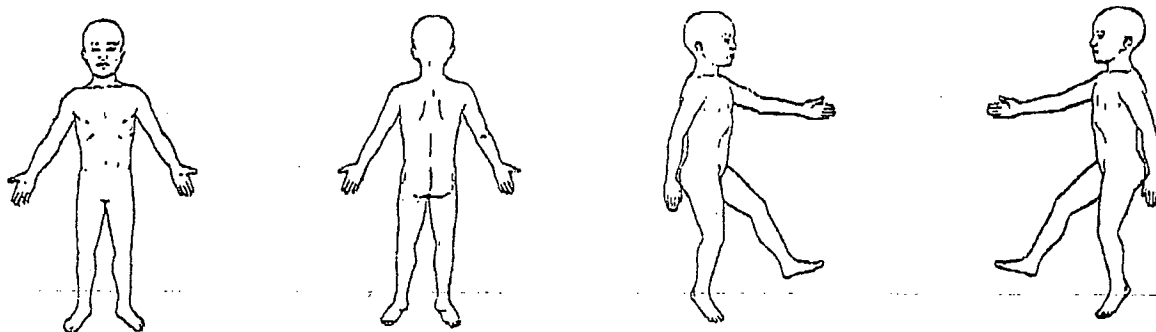
