

**JOINT MOTION FOR EXTENSION OF TIME**

PLEASE TAKE NOTICE that Appellant/Respondent Town of Arcadia Lakes and Respondent/Appellant Roper Pond, LLC hereby jointly move the Court for an Order extending the time for filing Initial Reply Briefs.<sup>1</sup> The parties request a ten (10) day extension of the filing deadline, which currently falls on February 28, 2018. 

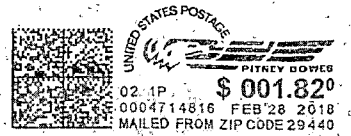
