

Since I believe this is a second copy, please charge me the reduced copy price provided in the Court Reporter Rules Manual.

March 17, 2017 Transcript: On July 1, 2017, I requested a verbatim Transcript of the March 17 hearing, which you provided. I requested that all statements made during the course of the proceeding be transcribed in accord with Section VI of the Court Reporter Manual. In reviewing the Transcript I observed that an audible statement was omitted from page 13, as requested in my July 1 and September 11 letters. Challenge is again made to the omission of the clearly audible statement heard by one or more persons in the court room and I again request you correct the record. Statements made by a Judge during a hearing on the record from the bench are not protected by any judicial privilege in my opinion. 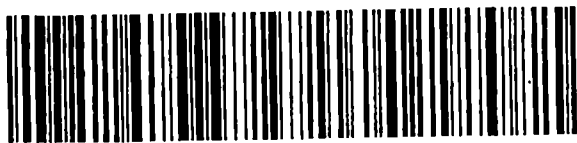

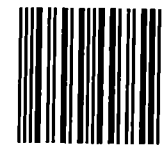
