

Counsel filed the Anders brief of appellant and Record on Appeal in the case of State v. Malcolm Williams in this Court on January, 8, 2018. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Charvus Nesbitt v. State in the Supreme Court on January 5, 2018. Counsel filed the petition for writ of certiorari to this Court in the case of State v. Keith Burris in the Supreme Court on January 4, 2018.

3. This request is made in good faith, and not for purposes of delay.


4. As indicated by his consent below, counsel for the state graciously consents to or does not oppose this request.


