To whom this Concerns;

I'm assuring this would go to the tribunal Court Judge or person in charge of these matter's. My appeal was originally denied because of the lack to produce sufficient grounds of my appeal. I was in orientation status and therefore had no access to a law library unless of self representation, until transfer. My remittitur letter was just received by me on Feb. 22 of 2018 the same this letter is being wrote, If you could please inform me of the process such as Forms or simple writing a letter for reasons which I will in this letter to receive a granted appeal I do believe whole heartedly that my grounds are sufficient enough.

My Solicitor was switched 3 times and things pertaining to my case I believe my Solicitor was bias and prejudices against my situation because she is a Woman, I was originally and wrongfully accused of CSM with intent to commit rape, the charge was ignored not dismissed because a sexual assault never accused, it was an assumption of the Detectives with absolutely no evidence, even the victim was asked and she stated "no

she did not believe my intent was to rape her. Based on these facts my Solicitor was upset they could not keep this charge on me because of the Media and criminal record I have as a Juvenil wich is a whole nother story of something that never occused but was convicted because of a violation of Juvenil probation stipulation that the Judge placed on me stating dismissle apon completion. Anyways that is not my grounds for appeal, my grounds is I was rushed into pleading guilty, felt I had no other choice exep conviction by the talk and slander of my case. I hired an attorney 1 month prior to learning that I was not going to be coming to an agreement with the Solicitor, I was scared and highly medicated early that morning before Court, with prior meds the night before that came very late so the new meds I just started clouded my Judgment, I did not even realize they were having the effect on me until I was just so scared for the rest of my life being free I threw myself at the mercy of the court by admitting my intentions, wich were none crime related with permission to enter the residence on deciet, but not with intent to commit a crime, only to call for a ride on a addiction related event, I was desperate to use telephone and tried to buy time for my phone, machine was broke at

Store, even asked to use store telephone but was denied. I then see my neighbor with I've spoke to several times and asked to use telephone with ~~the~~ reasons untrue because I hide my addiction not because I was intent on committing a crime. My victim a Triston Thornhill I know only as Triston went inside her house/apt I asked to come in because it was cold outside on a October night, she granted permission and everything I'm writing now matches her statement. I did use the phone, she heard me speaking with several people on phone so I was not lying about needing to use the phone she did say that, I could not find side from my person. Another set of events happened with I can not comment because I don't want words used against me or know how this letter can be used (as evidence perchance) but needless to say I never took anything in the house, had a weapon, only a conflict between 2 persons happened which was unrelated to coming in the home as to say my intention was to do harm or a crime that is absolutely not true. I have some mental problems such as schizophrenia and I'm dilectic but have fought myself how to bypass these things sometimes. The conflict I believe has to do with my schizophrenia because I would like to say this as was written on my actions not my confession that assault happened during the

assumed Burglary 1st degree, Kidnapping charge by
 continuing in an aggression in the situation because
 when touched schizophrenics don't react very
 well especially not medicated as in my case, I'll
 admit to what I did do because I'm a man
 and want to take responsibility for my actions
 based on these facts of medications that
were new, double dosing without realization of the
 effect till afterward, and literally being scared for
 my life told that I have no chance because
 of the way the state would make my case
 seem like threw lies and lack of evidence that
 I had no chance, I wanted to sue for slander
 because it was stated that I did in fact by
 media and Face Book try to rape a women in
 her home when nothing was ever done or written
 in a statement by a victim, I lost family friends
 and the humiliation over the rape charge is
 unberable at times with my mental instability
 I need counseling to even consider that
 people can still see me as a good person. That I
 really am, I tried to talk with Solicitor and told
 all 3 that it all had to do with addictoon, I
 needed help, but because of the believe in the
 office of solicitors that I was getting off
 on intent crimes by hear say I doubt any took
 the time to read evidence so they believed what
 was spoken and did not even care about a prior

convicted felon's side because we as in general as a stereo type not a actual evil doing person with no morals, nowadays a simply shoplifting can make you a felon, drugs ruined my life from 16 til now, I was a straight A student, varsity football team in eleventh grade, attempted to go to collage while addicted to pain pills wich is the most horrible feeling in the world, I had the pain pill addiction because of a back injury wich led to heroin after my collage drop out in 2011 to Join The National Air force Guard to fix anything and everything I see or take apart for the greatest country in the world The UNITED STATES OF AMERICA I can't even Join the military because of my criminal History, Jobs were closed to me so I did do some crime but nothing that was not ever done to me by learned behavior, The problem is I don't deserve 15 years in prison for a burglary when people who have done Burglary 1st sentences in my county of 15 years and over are their on multiple Burglary 1st and get it droped to lesser offense wich is not a practice in law books onley a severity of a crime. I deserve a whole complete retype of evidence presented in front of Solicitors that know nothing of my case especially Women, because Women are very prejudice against

men who try to rape people because it is different from a woman's point of view, disgust, lust, no respect for women like that has caused crime to men just out of hatred why wouldn't a woman try to over convict a man with the same type of feelings which all people have and act on. I deserve a rehabilitation program after a sentence on my regular assault because of mental problems I believe a little leniency should be shown upon me being medicated and monitored with a sentence over my head after I'm stable to punish me if I decide to make the wrong decisions after the real issue is addressed. These things should be fixed not pushed into a whole in prison with people who stab each other, fight, among other things before this I've been in prison for assault and probation violation, both drug related for 2 to three months, that was not the answer, I was not even asked if I needed help or observed to see the real issue, please help me represent my case in a new light, a fair chance that fixes the incorrections in my behavior, not just thrown in prison to get out the same person of mind. Prison is abused and misused on people like me who are overlooked and judged immediately upon record and not the true person.

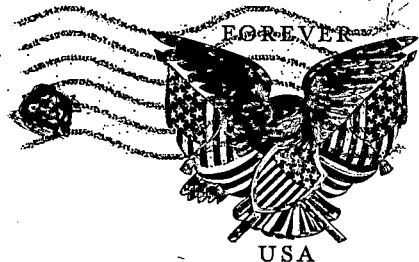
